Ten Pearland ISD students to compete at State VASE Competition



Student artists from Dawson High School, Turner College and Career High School and Pearland High School are set to compete at the State Visual Arts Scholastic Event to be held April 29-30. Students qualified after participating in the regional event held in February.

Advancing students include DHS's Sophia Fu, Jack Liu, Cate Mercado, Aruna Muthupillai and Hannah Patterson (teacher Teri Zuteck); Turner CCHS's Joshua Tennessee, Emma Lawrence and Sinsha Bakshi, (teacher Mark Villalpando) and PHS's Emily Anderson and Savannah Miller (teachers are Maryam Sohail and Alyssa Hartgove).

Texas High School VASE began its 28th season in January of 2022.

The first VASE event was held in 1994 with just over 400 student entries; in 2019, approximately 37,000 artworks were entered in VASE.

Students create artworks, write about their creative processes and understanding of visual art, and articulate information about their artwork during an interview with a VASE juror, who evaluates their work using a standards-based rubric. Art jurors look for originality, technical expertise, understanding of visual art and interpretation of the student's stated intent.

Only the top 10% of each division's artworks at the Regional level were selected to advance to the High School VASE State Event, with more than 2,300 entries advancing.

Pearland ISD students currently in grades 6-11 who plan on participating in any athletics class, sport, high school marching band, drill team or cheerleading for the 2022-23 school year may attend. Please bring contacts or glasses to the exam.

Limited tickets for the physical exam will be sold online only for \$25. Students must have a ticket for the appropriate time slot to enter the building for the physical exam. Pearland ISD will not accept students on the day of the physical exam that have not purchased a ticket online.

All athletic physicals must be dated on or after April 1, 2022, and completed on the Pearland ISD 2022-23 UIL Pre-participation Forms.

Students may also have their athletic physical completed by their family physician.

Dawson angler named to Bassmaster High School All-American Team

With the support of Pearland ISD and an amazing teacher, Charles Schulze, Jared Mizell and his family founded the Dawson Anglers in 2017.

As the founder and Dawson Anglers Club President, Jared has worked hard to encourage academic excellence and community service in Pearland High School youth. This club has grown from 5 two-angler teams (10 Pearland ISD students) in 2017 to 18 teams (35 anglers) in 5 years and has a projected growth of 5-10 more teams (an additional 10-20 high school students) for 2022-2023. Jared's efforts have extended to building a local scholarship program that benefits top performing Dawson Anglers and graduating seniors. In two years, the club has raised over \$40,000 for scholarships and distributed \$27,500 to 14 students in 2021 and 2022. Jared has personally logged over 500 volunteer hours concentrated in events bringing awareness to conservation and the great outdoors through the Houston Zoo, Texas Parks & Wildlife Kids Fish Fest, Bass Pro Shops Casting Clinic, and the CAST for Kids Foundation. After volunteering at a CAST for Kids event in April 2021, Jared has increased the club's commitment to community service by sponsoring a CAST for Kids event in Pearland where our Dawson Anglers will volunteer to support children with special needs through fishing.

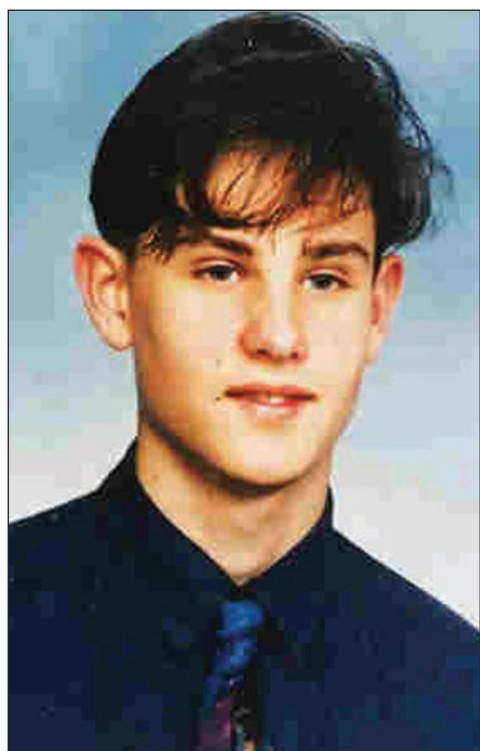

"Jesus came and stood among them and said, 'Peace be with you.'" ²⁰After he said this, he showed them his hands and his side. Then the disciples rejoiced when they saw the Lord. ²¹Jesus said to them again, "Peace be with you. As the Father has sent me, so I send you." ²²When he had said this, he breathed on them and said to them, "Receive the Holy Spirit. ²³If you forgive the sins of any, they are forgiven them; if you retain the sins of any, they are retained." ²⁴But Thomas (who was called the Twin), one of the twelve, was not with them when Jesus came. ²⁵So the other disciples told him, "We have seen the Lord." The game between Pearland and Shadow Creek was a hard-fought contest for the first four innings as the Oilers managed to score a run in the first and third innings for a close

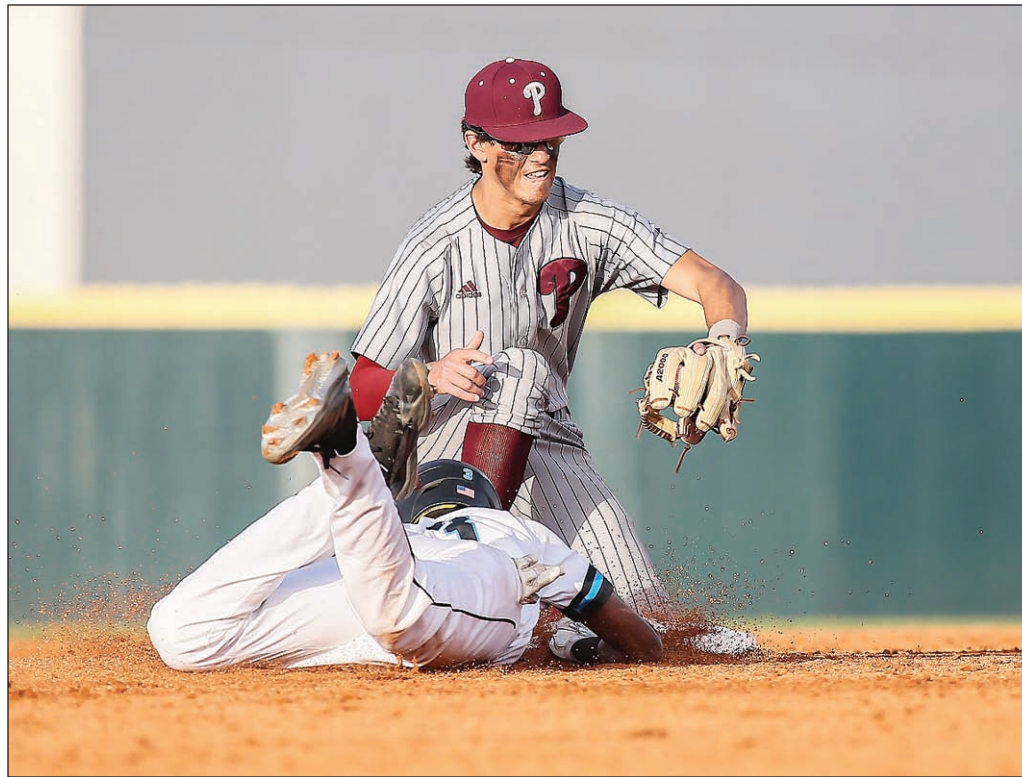

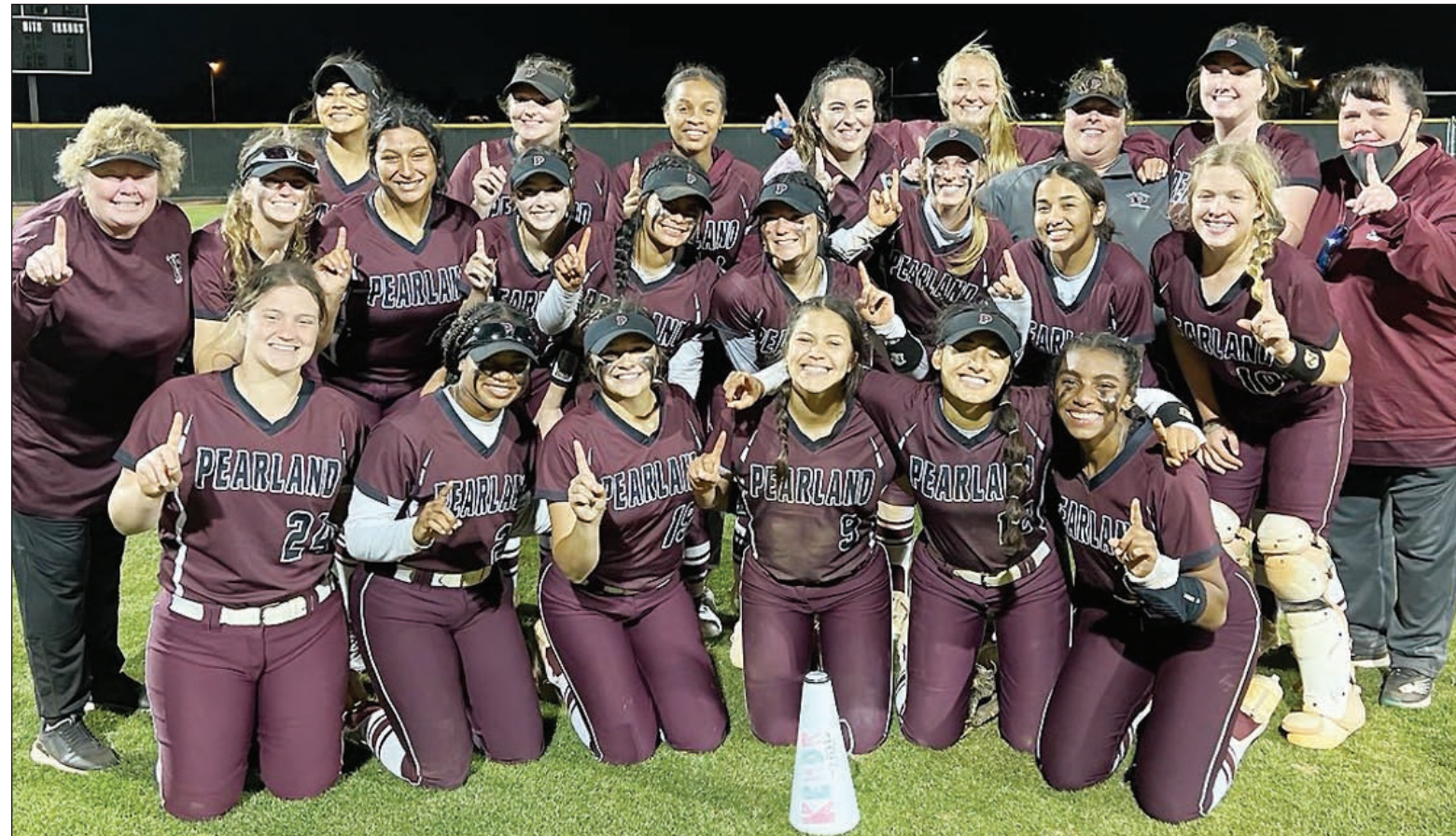
Gigi Solis was the winning pitcher as she allowed five hits, two runs, one walk, and struck out eight.
