## Westside **Event Center** has new name

The Westside Event Center has a new name after Pearland Council members discussed, amended the name and approved it at their regularly scheduled meeting Monday, May 9 at City Hall.

The new name is the West Pearland Community Center. The center is located at 2150 Country Place Parkway.

The Westside Event Center was originally built and managed by Municipal Utility District No. 5 (MUD 5). When the MUD dissolved in 2005 the City of Pearland Parks & Recreation assumed operations and maintenance of the facility.

Since that time the facility has evolved from an event rental center into a space that can be utilized for a variety of community purposes. The facility aims to provide space for meetings and small special events, as well as group activities, fitness, early childhood through senior adult recreation, public information, and educational opportunities for the Pearland community. The facility includes a banquet hall with commercial kitchen that accommodates recreational programs, voting, rentals such as weddings, baby showers, and birthday parties with less than 150 people, a meeting room, and two pre-school programming classrooms.

City staff consulted with the Parks, Recreation, and Beautification Board to offer naming suggestions and input for renaming the facility to encompass the variety of uses and benefits.

A representative from Parks and Recreation Department reported that they discussed the name to be Activity Center, Pearland Community Center, and Event Center. The center is the only community center in the city and they felt that the term West would make it seem like there were other community centers.

The new name was approved unanimously by the Council.





## Pearland receives ISO Class 1 rating

The Texas Department of Insurance presented City Council with an ISO Class 1 rating for the City of Pearland recently.

The ISO Class 1 rating represents a superior number of resources dedicated to fire protection and is the highest Public Protection Classification (PPC) attainable. The new ISO Class 1 rating places Pearland in the top one percent of all communities in the nation that have been issued an ISO grade in the PPC program.

Previously, the City was rated at Class 2, when the last ISO survey was conducted in 2015. In less than 15 years, the City has moved from an ISO Class 3 to an ISO Class 1, reflecting rapid improvements and significant investment in infrastructure, facilities, water supply and reliability, communications dispatch and overall fire protection services.

"A Class 1 means that we are meeting the highest standards for the integrated components needed to protect Pearland from fires," Fire Chief Vance Riley said.

"In addition, it provides opportunity for lower fire insurance premiums and aids our city in competition for economic development."

Communities whose ISO Class improves may get lower insurance rates, and fire departments receive a valuable benchmark when planning, budgeting, and justifying fire protection improvements.

According to the ISO, a community's grade depends on needed fire flows, emercommunications, water supply and the fire department's equipment, staffing, training, station distributions, operations, and risk reduction efforts.

"Achieving this rating requires a strong team effort across multiple city departments, direction from the City Manager with long term planning and supporting policy by City Council," Chief Riley said. "And we appreciate the study funded by Pearland Economic Development Corporation which lead to the information that we were eligible for this Class and could expedite our request to be

surveyed by the ISO."

The Insurance Services Office, Inc is the leading supplier of data and analytics for the property and casualty insurance industry. The rating will become effective July 1, 2022.

ISO's Public Protection Classification Program plays an important role in the underwriting process at insurance companies. The program is often used by insurance companies in deciding what coverages to offer or prices to charge for personal or commercial property insurance. The goal of the program is to accurately reflect a community's fire suppression and control resources.

Most insurers use PPC classification for underwriting and calculating premiums for residential, commercial and industrial properties. ISO visited the City to gather information needed to determine a public protection classification which may be used to develop property insurance premium calculations.

## THROW AWAY GODS

"So, the Israelites cried to the LORD, saying, "We have sinned against you, because we have abandoned our God and have served the Baals." -Judges 10:10

In 1979 I spent the summer on an archaeological dig at a place called Tel-el-Hesi... in the Negev desert a little over an hour's drive south and west of Jerusalem. In the earliest days of expeditions this site was thought to be Megiddo... the place where the battle of Armageddon is to take place. My Old Testament professor, the late Rev. Dr. Ralph Doermann said to me... "you either love archaeology or you hate it... but you won't know it unless you go do it." He was right. I loved it; but sadly, I have never returned... but yet, my memories of being there are like yesterday and because I was able to be present in this holy land... while still a seminary student... my understanding of scripture, especially the Old Testament and the life of Jesus has been amplified in my reading of the Bible and the Judeo-Christian faith I cling to daily.

During one of the days of digging, a friend was knee deep in an ash pit that would finally be determined to be a 2500 B.C. 'trash pile' as it was filled with broken pottery, olive pits, chicken bones and on that day the broken head of a Canaanite mantle god figurine who went by the name of Baal... (NOTE: The image above is a clay replica of the original about the size of a very plump strawberry). The lesson? Some gods break and are thrown away... with chicken bones and olive pits... or as in our culture... replaced with anything else that seems to make like easier.

Have you ever felt like God was broken? Have you ever given up on God... trying another way... acting like God has shattered and the only move left is to toss God in the closest nearby ash pit? Well, if so... you're not alone. It's not new.

The Bible tells us that Jesus was broken on our behalf... and one time even the good people of his hometown of Nazareth tried to toss him off a cliff after he told them he was the Messiah... long promised and long awaited... for stating the kingdom of God was near... as in right before their very eyes as he was the fulfillment of said kingdom. And not long after... as Jesus' body was placed in a tomb and as his disciples witnessed his untimely death... it might as well have felt like Jesus was no good now... not to anyone... being left in a cave... like part of a pile of trash... not knowing what was next and that his resurrection would need to be the means to make all the difference. Faith matters. Then and now.

I was speaking with some friends this morning and our conversation turned to the topic of atheists and agnostics... as there seems to be so many of them now... and how for some it has become the adoption of a 'life-style' in an effort and a way to reject Christianity... and I'll be the first to admit... it hasn't been completely a 'love your neighbor as yourself thing over the centuries with the Crusades and the Inquisition and all... taking on a convenient way of life to ignore what so many others find comforting, purposeful as well as challenging along the Christian path... as taking on the posture of not believing in God or a god at all is much easier than following in the steps of Jesus. After all, it's one thing for a Canaanite to toss a broken Baal figurine into the trash after falling off the mantle ... but who would dare do the same to Jesus and expect the same results? Jesus keeps showing up and keeps coming back... whole, loving, powerful and just...

And this... future archeologists won't find a broken Jesus at the landfill; but will surely find the broken things some have replaced Jesus with...








of the game in the top of the sixth inning on a run scoring double by Aubree Jones to cut the lead to 2-1, but Riassetto recovered to retire the next two hitters.

NONCONFORMING USES, STRUC-TURES AND LOTS," SUBSECTION B "NONCONFORMING USES," PARA-GRAPH 4; SECTION 7 "SCHEDULE OF DISTRICT REGULATIONS," SUB-SECTION C.1, SUBSECTION P.6 AND SUBSECTION Q; "SECTION 8 "SUP-PLEMENTARY DISTRICT REGULATIONS," SUBSECTION I "LANDSCAPING AND SCREENING REQUIREMENTS," PARAGRAPH 2.E(3)(B) AND PARA-GRAPH 2.F(3)(A)(III); AND "SECTION 20 "DEFINITIONS" OF THE FRIENDSWOOD CITY CODE TO REMOVE THE MULTI-FAMILY RESIDEN-TIAL (MFR) REFERENCE FROM THE GARDEN HOME DISTRICT (GHD) ZONING DISTRICT, TO ESTABLISH ARCHITECTURAL AND SITE RELATED REQUIREMENTS FOR GARDEN HOME DEVELOPMENTS, AND TO AMEND THE DEFINITION OF "DWELLING, GARDEN HOME"; PROVIDING A MAXI-MUM PENALTY OF TWO THOUSAND AND NO/100 DOLLARS (\$2,000.00); REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSIS-TENT OR IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY, PUB-LICATION AND AN EFFECTIVE DATE

It shall be unlawful to fail to comply with this Ordinance providing for the use and development of Garden Homes in the City of Friendswood.

A violation of this ordinance is subject to the penalty provisions contained in such Code under Section 1-14 "General penalty for violations of Code; continuing violations," and as otherwise provided by law. Any person who shall willfully, intentionally, or with criminal negligence violate any provision of this ordinance shall be deemed guilty of a misdemeanor and, upon conviction thereof, shall be fined in an amount not to exceed \$2,000.00. Each day of violation shall constitute a separate offense.
