Dawson concludes spring football practice

The Dawson Eagles ended their spring football practice with a strong showing in their spring game and head coach Mike Allison was pleased with what he saw from his coaching staff and players.

The Eagles lost about 36 seniors to graduation, but they will have a good number of lettermen returning for the fall of 2022 to be a strong and competitive team in their traditional winning program.

"I am excited about the things we have been able to accomplish throughout spring football this year," Allison said. "We lost some talented players to graduation, so this was a great opportunity for others to step in and show what they are capable of. We have a good number of lettermen coming back, and I was glad to see that the hard work they have put in throughout the off-season has helped them improve."

Dawson finished with a solid 8-4 mark in 2021 while advancing to the second round of the post-season.

A third place finish in District 23-6A behind Shadow Creek and Pearland placed them in the Class 6A Region III Div. II bracket where they beat Clear Falls 35-31 in the bi-district round. The Eagles avenged an earlier 31-7 loss to Clear Falls in the season opener. Summer Creek ended the season for Dawson in the area round.

"The coaching staff did a great job of working together, and with the athletes, to get the most out of each practice," Allison pointed out. "We have set a solid foundation for the fall, and will continue to work throughout the summer in order to give us the best chance for success when the season gets here."

Dawson will open the 2022 football season at Pearland ISD Stadium against the Hightower Hurricanes on Friday, August 26 at 7:00 p.m.



Reflections of a Student Reporter

In my three years writing for the FHS Lariat, I learned the fifteen-year-old girl that I was, I was reduced to a flusnumerous invaluable lessons. From embarrassing myself in tered, stammering mess when I found myself interviewing front of an unexpectedly attractive interviewee, to being an unexpectedly attractive senior.

taught how to write an editorial by a senior who forgot I was in her class, or interviewing a woman whose family is experiencing the war in Ukraine, every lesson has proved to promote growth.

It can be easy to fall into the trap of believing that writing is monotonous – the times I think there isn't a single interesting thing happening that could *possibly* be worth writing about. But that trap, the Monster of Monotony, is just potential in disguise. It has made me realize that a story can hide in anything.

In speaking to a local woman whose family

still remains in Ukraine, what began for me as an everyday article about a local fundraiser turned into a learning experience about the true impact of war, not just on the other side of the world, but in our community.

I began writing the article expecting it to be important because the cause was important. I was wrong; it was lifechanging.

But not all of the lessons I learned through writing articles were deep and emotional. Some of them were learned through completely embarrassing circumstances. While writing one of my first articles, I scheduled an interview with a student who was several years older than me. Being



During this painfully awkward interview, I stuttered through every question I asked, dropped my pen on the floor about seventeen times, all the while the boy I was interviewing was considerate, even picking my pen up for me and shaking my hand when we finished. While this interview was not my best, nor was it for a serious topic, it taught me the value of preparing for an article and expecting the unexpected.

I've interviewed an eclectic mix of people over the last few years: homecoming queens, student athletes, exchange students, even an

FBI computer scientist. Unfortunately not every interview or story is able to be published, whether that be for the sake of privacy or just due to time constraints. Most of the time, a published article contains only a small fraction of the information I learned, however the personal growth experienced from each article cannot be measured.

Yet each interview tells a story and reiterates the true individuality of every person I encounter. I have not only learned how to write an editorial or properly format a headline, but also how to speak to people and find that there is a story in anything.

Electric Reliability Council speaks on grid conditions

Electric Reliability Council of Texas Interim CEO, Brad Jones is communicating with Texans on current grid conditions.

With unseasonably hot weather driving record demand across Texas, ERCOT continues to work closely with the power industry to make sure Texans have the power they need.

Recently, six power generation facilities tripped offline resulting in the loss of approximately 2,900 MW of electricity. At this time, all generation resources available are operating.

The Council is asking Texans to conserve power when they can by setting their thermostats to 78-degrees or above and avoiding the usage of large appliances (such as dishwashers, washers and dryers) during peak hours between 3 and 8 pm through the weekend.

ERCOT, the Electric Reliability Council of Texas, manages the flow of electric power to more than 26 million Texas customers, representing about 90 percent of the state's electric load. As the Independent System Operator for the region, ERCOT schedules power on an electric grid that connects more than 52,700+ miles of transmission lines and 1,030+ generation units, including PUNs.

ERCOT also performs financial settlement for the competitive wholesale bulk-power market and administers retail switching for more than 8 million premises in competitive choice areas.

PEDC showcases ERSCAT as part of project history

In celebration of National Economic Development week held recently, the Pearland Economic Development Corporation looked back at some of PEDC's projects over its 25-year history.

They showcased Energy Rental Solutions (ERS-CAT). Energy Rental Solutions (ERS), a Caterpillar dealer dedicated to the specialty rental business, relocated its new headquarters to Pearland in 2019. The 40,000 square-foot building includes office and warehouse space and is located on a 12-acre site on Rice Drier Road and State Highway 35.

The facility brought more than \$4 million in capital investment to Pearland and is home to approximately 55 employees, including executive management, sales, operations, administrative, service technicians, and warehouse personnel.

PEDC worked with a private developer to persuade ERS to select a site in the Rice Drier redevelopment area that is part of the area identified as Business Park North in the State Highway 35 Redevelopment Strategy. PEDC and the City partnered with the developer to improve the infrastructure in the area including drainage and the reconstruction of Rice Drier Road. PEDC committed almost \$3.5 million in infrastructure to the area that will support more than 58 acres of development.

Both satellite offices close one hour for lunch from Noon to 1 pm.

LET'S BE FAITHFUL OUT THERE

"And we urge you, brothers, and sisters, to admonish the idlers, encourage the fainthearted, help the weak, be patient with all of them. 15 See that none of you repays evil for evil, but always seek to do good to one another and to all. Rejoice always, pray without ceasing, 18 give thanks in all circumstances, for this is the will of God in Christ Jesus for you."

~ 1 Thessalonians 5:14-18 In the old TV show, "Hill Street Blues" the police officers gathered with each shift in the day room to get the lay of the land in the city before going out to tend to their post. At the end of each briefing Sgt. Phillip Esterhaus dismissed everyone... with what became a catch phrase for all... imparting a caution to the officers policing the streets with the words... "Be careful out there..." as this was actually something in the control of each police officer as everyone knew the streets were full of danger.

The streets can be full of danger. How do I know? I read the papers. I watch the news. I listen to the radio. I've walked those streets. In my four decades as a pastor, I was invited into many pain-filled stories of people I loved deeply. I also was the pastor to many police officers, some who worked in the Sherrif's office, two who worked for the Texas Department of Public Safety and even a U.S. Marshall and an FBI agent who shared with me in confidence some very grueling stuff... and I'll just stop at that... while being thankful they had a safe space to pause to unburden themselves of the danger they encountered ...

And as I write these words today, I'm mindful of some dangerous stories that have entered the news waves over the last 72 hours with 325 unnecessary and hateful shootings around the country with the most grievous taking place in Buffalo, NY... killing 10 and injuring three others with all indications seemingly to be a hate crime with racial motivations. Dangerous streets indeed. It makes me wonder...did this 18year-old young man have a pastor? Did his parents take him to Sunday School and church? Could he point to one or two other adult males he could tag as a 'mentor'? I'm not sure and even if he did there are no guarantees...kind of like the police sergeant needing to say..."Be careful out there ... " each and every day...not just every once in a while...but...let's face it...there's more to it.

Jesus had a different take on going out into the world... he admonished his disciples to carry their faith into the world... like lambs in the midst of wolves... but sent... nonetheless. He did not want his friends to live in fear but to rather have a faith which could move mountains... saying... "Do not let your hearts be troubled. Believe in God; believe also in me..." and saying things to them like... "love your enemies," and "pray for those who persecute you..." as well as... "love God... love your neighbor and love yourself..." a three-fold recipe for living a full and productive life as anyone who spends all their waking moments acting on those three key things for life has time to target a grocery store full of strangers and open fire on them... this being Jesus way of saying... What do warblers, tanagers and flycatchers have in common? Besides being colorful

showstoppers, these little birds are among the many that can be seen in Pearland in the spring. Starting in April, flocks of these lively songbirds, including yellow and hooded warblers and great crested flycatchers, pass through town on their seasonal migration routes.

Cross these birds off of your bucket list at either the Shadow Creek Ranch Nature Trail or the John Hargrove Environmental Center (for best results, go at dusk or dawn). Bring a pair of binoculars and find a quiet spot on a nature trail where you can hold still for a while to let the birds get used to your presence. Keep an eye out and you may see as many as 20 different species of songbirds, if

To see waterfowl, find your way to the John Hargrove Environmental Complex & Wetlands. Boasting the first municipal

floating wetlands in Texas, the complex is routinely home to hundreds of nesting pairs that form rookeries. Explore the 1.7-mile nature trail and you'll encounter

such friendly fliers as roseate spoonbills, American white pelicans and even blue jays and bald eagles. For a real treat, visit the Fite Road Bridge at dusk to see the emergence of the local bat colony.

Both of these parks offer more than enough to keep you busy, but there's more. The nearby El Franco Lee Park in Houston is an 80-acre expanse of protected wetlands commonly visited by northern harriers, vermilion flycatchers and orange-crowned warblers in the spring. Exploring each of these three sites is an adventure all its own, but having them all in one place means you could easily dedicate your entire visit to birding.

Pearland (30-7) advances to the 6A Region III semifinals where they will face another stout opponent in the Katy Lady Tigers who are 29-4 on the season.

Head coach and Texas Girls Coaches Hall of Famer Laneigh Clark is no stranger to her girls being in this position in the playoffs after being at the helm of the Lady Oilers for 25 years.

The Lady Oilers plated two runs in the top of the first inning aided by a pair of Clear Springs miscues in the field.

UT Orthopedic physicians who already serve the Pearland community, such as Dr. Taggart Gauvain, Assistant Professor in the Department of Orthopedic Surgery at McGovern Medical School at UTHealth Houston and orthopedic surgeon affiliated with Memorial Hermann Pearland Hospital.

"Our goal is to provide Pearland and the surrounding communities advanced and specialized orthopedic care in all areas including sports medicine, joint replacement, foot and ankle surgery, hand surgery, pediatric surgery, and concussion management, as well as physical medicine and rehabilitation," said Dr. Gauvain. "Our partnership with Memorial Hermann and ATH will bring the highest level of physical therapy rehabilitation and athletic training under the same roof to offer a seamless experience as we work diligently to care for our patients."

In addition to a UT Orthopedics clinic, the facility will also host a Memorial Hermann IRONMAN Sports Medicine Institute clinic, physicians with sports medicine training, and an ATH training center with an adult fitness space, pro-style weight

room and an indoor turf field for performance training. The facility will also have an outdoor turf field to host a variety of community sports leagues including soccer, football and lacrosse.

"We're excited to expand our collaboration with Memorial Hermann and UT Physicians Orthopedics into Pearland," said Chris Slocum, Senior Director of Athletic Performance with Athlete Training and Health. "Not only will we bring award-winning, science-backed adult fitness and sports performance training to the Pearland community, but through this collaboration, we can also help injured athletes get back to their sport quicker by providing all of the surgery, rehabilitation, post-rehabilitation and training services they'll need in one spot. There is an increasing need for 360-degree care, including preventative care, and this all-star collaboration provides just that."

Slated to open in spring 2023, the 50,000-square-foot facility represents a \$15 million investment in the community.

A similar facility, Memorial Hermann Sports Park-Katy, opened in fall 2019.
