DHS team places first at **UIL Academic State Meet**

Dawson High School recently participated in the 2022 UIL Academic State Meet in social studies, ready writing and science. The social studies team representing the school took the gold in their category.

At the UIL academic meet, participants earned points for their school team in different subject areas. The following team placed in their category:

- **Social Studies: First Place Team**
- Lauren Cross (5th place overall)
- Rishabh Dave (3rd place overall)
- Fred Guo
- Tanmay Savargaonkar
- Coach: Deidre Brady

Also competing were Hantao Jin who placed 2nd in the spelling and vocabulary category and was coached by Kerry Burkett, Jacqueline Xiong who placed 2nd in literary criticism and was coached by Jessica Myers and Ethan Loyless who placed 5th in ready writing and was coached by Leslie Sanderson.

The four events DHS competed in at state were comprised of a multiple-choice tests and essays over the subject material.

The social studies test had 45 multiplechoice questions with an essay over the subject material. In the ready writing contest students were given a choice between 2 prompts to write an expository essay. The spelling and vocabulary contest consisted of multiple-choice questions covering proofreading and vocabulary, and words written from dictation. The literary criticism contest involved multiple-choice questions which required students to use literary judgment and to analyze literary passages from both the reading list and other sources. If a tiebreaker was required, the student would write a short essay dealing with a specified topic about a selected literary passage from both the reading list and other sources.

Students were eligible to advance to state as an individual if they placed in the top three in the region or as the top team in the region. These students competed against students from eight high schools at the district level and seven districts at the regional level to advance to state.

The University Interscholastic League offers a wide variety of academic contests for high school students, encompassing many elements of required high school coursework. These contests build upon the academic skills developed in the classroom and offer students an opportunity to stretch their talents above and beyond those requirements.

UIL Academics activities, which exist to complement the academic curriculum, are designed to motivate students as they acquire higher levels of knowledge, to challenge students to confront issues of importance and to provide students with the opportunity to demonstrate mastery of specific skills. Library to host annual **Ekphrastic Poetry Festival**

Submissions for the 2022 Ekphrastic Poetry Festival are underway by the Friendswood Library. Poems submitted will be considered for the 2022 Reading and Contest to be held at a later date.

An ekphrastic poem is defined by the Poetry Foundation as a vivid description of a scene or, more commonly, a work of art. Through the imaginative act of narrating and reflecting on the "action" of a painting or sculpture, the poet may amplify and expand its meaning.

One of the earliest examples is in Homer's the *Iliad* where he describes the Shield of Achilles. Another example is in Ode on a Grecian Urn by John Keats. The poet speculates the identity of the lovers who appear frozen in time on the urn dancing and playing music.

In the Friendswood contest, poets may submit one to three ekphrastic poems to Library Director Matt Riley mriley@firendswood.com.

Poets should identify the specific work of art that each poem addresses.

All poems will be considered for a 2023 poetry anthology put together by the library. The contest will be judged by a blind jury. No self portrait artwork, names or contact information should be on the Word document with the poems.

Participants should type Ekphrastic Poetry in the subject line of their email and have their name, phone number, name of poem(s), names of artwork and artist and short bio in the body of the email.

Only works of art in the public domain or works of art where the poet is the copyright owner or can submit direct permission from the copyright owner will be considered for the contest and anthology.

The deadline for all submissions is July 31, 2022 at midnight.

Pearland ISD celebrates Better Hearing, Speech Month

In honor of Better Hearing and Speech Month in May, Pearland Independent School District recognizes its professional speech-language pathologists (SLPs) for supporting the academic success of students with hearing and communication challenges.

Pearland ISD's 27 SLPs help prevent, identify, assess and treat speech and language problems that impact students' achievement.

"Speech-language pathologists work with people every day in settings that include schools, private practices, health care facilities and even their own homes to improve their speech, language, social and cognitive skills," said Pearland ISD lead SLP Mary Kate Puna.

According to many SLPs, children today are at great risk of hearing loss from unsafe use of personal audio devices and exposure to noisy activities. Guidelines from the World Health Organization recommend that children spend no more than 40 hours listening to a personal audio device per week, at levels no higher than 75 decibels, to prevent hearing damage. Many technology devices and accessories reach volumes above 100 decibels, and even headphones marketed as "kid safe" routinely exceed 85 or even 90 decibels. This makes ongoing vigilance important.

Puna advises that the following simple steps can help protect children's hearing:

Turn the volume down (even on "vol-

ume-limiting" products). Some headphones claim to have maximum noise output levels that won't damage hearing. But studies have shown that these claims aren't always reliable and offer a false sense of security. The best bet is for kids to keep the volume at half level.

Use noise-canceling earbuds/headphones. Noise-canceling earbuds or headphones can reduce the need to crank up the volume and help kids hear better by drowning out external noise.

Take regular listening breaks. Encourage kids to give their ears a rest and take hourly breaks, even if just for a few minutes. The potential for hearing damage hinges on how long a person listens as much as how *loud* they listen.

Model safe use. Practice what you preach by watching your own volume and taking other prevention steps. You'll be a great example-and you'll protect your own hearing, too.

Help children appreciate their hearing. Talk to kids about why safe listening is important, so they understand that you aren't just nagging. Let them know that hearing is something to value and that they should want to continue enjoying their entertainment (and more) for years to come.


