

Rogers, Maxcey named All-Greater Houston "Players of the Year"

The Friendswood diamondmen completed their most successful season in school

history when they advanced to the Class 5A state title game while posting a 30-8-1 overall record. While head coach Cory Benavides had outstanding players on the team that contributed to the overall success this season,

two players were recently honored as the All-Greater Houston "Pitcher of the Year" and "Hitter of the Year." Jacob Rogers earned the top pitcher award after he finished with a 1.65 ERA

over 76 innings while also collecting 89 strikeouts, and 33 walks.

The righthander beat Mansfield Legacy in the 5A state semifinals 4-2 to send the Mustangs to the state title contest. Rogers allowed only five hits in six innings.to get the win.

Dylan Maxcey was Rogers battery mate and they proved to be one of the best pitcher/catcher combinations in the nation. Maxcey certainly did his part as he was named as the top hitter with a .468 batting average that included 59 hits, 21 doubles, two triples, five home runs, 31 RBIs, 37 runs scored, and 10 stolen bases. He also posted a .989 fielding percentage behind the plate.

The pair will continue being teammates as Rogers and Maxcey will both continue their education and playing careers for the Texas Tech Red Raiders in Lubbock.

West Ranch shares annual report with City Council

The annual report of the West Ranch District Management was presented to Friendswood City Council at their regular meeting at City Hall on July 11.

West Ranch is composed of 766 acres. Board members include President Brian Gibson, VP and Asst. Secretary Sawyer Blackburn, Secretary Doug Konopka, and directors Meredith Levine and Joe Matranga. It was reported that the residential develop-

ment is complete. The new Cline Elementary is under construction and that only commercial tracts remain to be developed.

The West Ranch HOA owns most of the greenspace around the roads and recreation centers. WRMD still owns and manages the property next to Chigger Creek, Clear Creek and the retention ponds.

WRMD provided an ongoing drainage maintenance update. The District continues to use Storm Water Solutions (SWS) to perform quarterly inspections of all WRMD owned and operated drainage and detention facilities.

Over the past three years, WRMD has spent approximately \$105,000, over and above routine mowing, on drainage maintenance and rehab (i.e. desilting of channels, removal of vegetation and overgrowth, erosion repair, structural outfall repair, etc.) to ensure that all drainage and detention facilities are in good working condition and function as originally designed

WRMD recently completed a joint project working with the West Ranch HOA to improve common areas. The two groups rebuilt the West Ranch fishing pier on Clear Creek.

Goals and objectives for the area were also shared with Council. The board remains focused on lowering West Ranch homeowner costs, identifying sensible opportunities to pay off existing bonds and the prudent man-

agement of district property. Friendswood Development Company is still seeking a potential town center developer for the commercial property. There are approximately 45 acres of commercial development remains near the intersection of FM 518 and West Boulevard and approximately 13 acres of commercial property remains near the intersection of West Boulevard and Friendswood Parkway.

The City Manager's Report provided the Council with information on the upcoming Movies in the Park as well as the Library Town Meeting.

Friendswood VFD nationally recognized for its commitment to quality care for severe heart attacks in Friendswood. At the recent meeting of Friendswood City Council, the members were told about an award presented to VFD EMS in the city.

Friendswood VFD EMS has received the 2022 American Heart Association's Mission:

Lifeline® EMS Gold Plus achievement award for its commitment to offering rapid, researchbased care to people experiencing the most severe form of heart attack, ultimately saving

This is the 6th consecutive year that Friendswood VFD EMS has reached the Gold

Each year, more than 250,000 people experience a type of heart attack known as an ST elevation myocardial infarction (STEMI),

caused by a blockage of blood flow to the

heart that requires timely treatment. To prevent death, it is critical to restore blood flow as quickly as possible by either mechanically opening the blocked vessel or using clot-busting medication.

Mission: Lifeline is the American Heart Association's national initiative to advance the system of care for patients with high-risk, time-sensitive disease states, such as severe heart attacks. The program helps reduce barriers to prompt treatment for heart attacks starting from when 911 is called, to EMS transport and continuing through hospital treatment and discharge. Optimal care for heart attack patients takes coordination between the individual hospital, EMS and health care system.

"The health care professionals who interact with a patient even before he or she enters the hospital or emergency room play a vital part

in the system of care for those who have heart

attacks," said James G. Jollis, M.D., volunteer

chair for the GWTG-CAD Systems of Care Advisory Work Group and professor of medicine at Duke University School of Medicine. "Since they are the first medical point of contact, they can save precious minutes of treatment time by activating the emergency response system that alerts hospitals to an

incoming heart attack patient." The Mission: Lifeline achievement award is earned by agencies that demonstrate a commitment to treating patients according to the most up-to-date research-based practices as outlined by the American Heart Association.

"Friendswood VFD EMS and Fire divisions are honored to be recognized by the American Heart Association for our dedication to providing optimal care for heart attack patients," said EMS Chief Lisa Camp. "The Mission: Lifeline program puts proven knowledge and guidelines to work on a daily basis so patients have the best possible chance of survival."




FAITH MATTERS

The following criteria will be used to determine a child's eligibility for free or reduced-price meal benefits:

eligibility levels Categorical or Automatic Eligibility: Household receiving Supplemental Nutrition Assistance Program (SNAP).

Income: Household income that is at or below the income

Temporary Assistance for Needy Families (TANF) or Food Distribution Program on Indian Reservations (FDPIR) Program Participant: Child's status as a foster child,

homeless, runaway, migrant or displaced by a declared disaster or child's enrollment in Head Start or Even Start

Income Eligibility

For those households that qualify for free or reduced-price meals based on income, an adult in the household must fill out a free and reduced-price meal application online or submit a paper application to the Food Service Office (1928 N. Main) or to their child's campus.

Those individuals filling out the application must provide the following information:

Names of all household members

Amount, frequency and source of current income for each household member

Last four digits of the Social Security number of the adult household member who signs the application (if the adult does not have a Social Security number, check the box for "NO SSN")

Signature of an adult household member attesting that the information provided is correct

Categorical or Program Eligibility

Pearland ISD works with local agencies to identify all children who are categorically and program eligible.

The Food Service Department will notify the households of these children that they do not need to complete an appli-

Any household that wishes to decline benefits should contact the Food Service Office at 281-412-1244. Applications may be submitted anytime during the school

year. The information households provide on the application will be used for determining eligibility. Applications may also be verified by the school officials at any time during the school year. **Determining Eligibility**

Households or guardians dissatisfied with the reviewing official's eligibility determination may wish to discuss the decision with the reviewing official on an informal basis.

UHCL Pearland offers drone pilot training, preparation for FAA pilot certification

With the expansion of drone applications across almost all sectors of industry, University of Houston-Clear Lake Pearland campus is answering the call to offer training to become a licensed professional drone pilot. In partnership with DartDrones, one of the nation's leaders in drone training, UH-Clear Lake Pearland Continuing Education is offering a 3-day basic sUAS flight training and 107 pilot test preparation program for those who seek to gain professional drone piloting skills necessary for FAA certification.

The Drone Academy will take place Aug. 5-8 from 8 a.m. to 5 p.m. at the UHCL-Pearland campus. There are four in-person courses: Basic Drone Operator, Aerial Mapping and Modeling, Public Safety and Emergency Response, Inspection.

Executive Director for Professional Education and Extended Programs Lisa Gabriel said the need for skilled, certified drone pilots was increasing in nearly every area. "Energy and construction companies need drone pilots to do inspections and mapping," she said. "There is also a great need for pilots in police and public safety departments, the military, agriculturethey're needed almost everywhere."

The Association for Unmanned Vehicle Systems International predicts that by 2025, at least 100,000 jobs will be created for qualified, licensed drone pilots, with job growth continuing over the next five years.

She added that regardless of what specialized sector a pilot chose to pursue, the training and certification offered by the Drone Academy was foundational and would be the starting point for all pilots.

"When you're done, you will be ready to sit for the licensing exam," she said. "For anyone serious about a career in the drone piloting industry, this training is versatile and certainly in demand."

Drone Academy instructors are experienced in aviation and U.S. Army sUAS operations and can help a future drone pilot on their way to a career in mapping, inspections, disaster response, aerial photography, night operations and more.

Dawson's gridiron warriors to challenge for district title

It has been four years since Dawson head coach Mike Allison took over the helm of the Dawson football fortunes, and he has certainly continued the foundation that was laid when the school opened in 2007 with former head coach Eric Wells in charge.

Coach Allison was a part of the beginning for the Eagles as the defensive coordinator, so he was no stranger to Dawson upon returning to the Eagles after a short absence for three-years as the head coach at Clear Brook High School.

This will be the fifth year for coach Allison after posting a 34-12 record for his first four years while also advancing to the area round of the playoffs all four seasons.

Coach Allison is always the first to give credit to his players and dedicated coaching staff regarding their accomplishments. The players and coaches know how to get along with one another which is a great asset when transferring information to young high school players.

The Eagles have always been a team that will be highly competitive no matter who they are playing. While they may play a team with more talent, Dawson will never be out coached which stood true with former head coach Eric Wells and now, with coach Allison and his staff.

The Eagles will have a strong non-district schedule as the Eagles will play the Hightower Hurricanes (11-3), the Klein Collins Tigers (6-5), and the Tomball Cougars (11-4). These three teams were a combined 28-12 in 2021 with Tomball advancing to the 6A DII state semifinals. This schedule will prepare Dawson for district competition.

Looking forward to the 2022 football season, Dawson returns six offensive and seven defensive starters with 30 returning lettermen on a team that was 8-4Olast season while advancing to the 6A DII area round.

Dawson is a pre-season pick to finish second in District 23-6A behind Shadow Creek, but they were a pre-season pick to finish third in 2020, but they went undefeated in league play to win the district championship. They have captured the league title the past two out of three years.

Offensively, the Eagles should be experi-

enced with a wealth of talent starting with three-year starting quarterback senior Colin Johnson who was 143-of-243 passing for 2,044 yards, 17 TDs and only 2 INTs last season. Johnson also rushed for a pair of touchdowns. While he has a strong arm through the airways, Dawson would really benefit Johnson's ability to also run the ball when that would be a better option to keep drives alive making him a dual threat on offense.

Another big-time player is junior running back Bryce Burgess who was named the district's "Offensive Newcomer of the Year" last year after rushing for 1,423 yards on 190 carries for 16 TDs while catching nine passes for 79 yards and two scores. Burgess is a threat to score every time he carries the ball.

Other players that will give Dawson an explosive offense are OL Grant Petru (6-2, 275), TE Charles Anderson (6-6, 225), RB/LB Jeremiah Treadway (5-9, 170), and OL David Escobedo.

Defensively, the Eagles should be strong, especially at the beginning of the season. Leading the way for Dawson will be LB Jackson Cody (6-1, 220) who had 88 tackles, 15 stops for loss, 3 sacks, and 1 INT. DL Chris Herpin (6-1, 305) will also be a force on that side of the ball.

Other standout players include: DL Edward Smith (6-6, 230), DB Max Menendez (5-10, 165), and DB Bryson Burness.


