Bond committee presents report to Council

Citizens Drainage Bond Advisory Committee presented an update to the Pearland City Council at their regular meeting July 11 at City Hall. Council by Committee Chair Seth Thompson prepared the update.

The Citizens Drainage Bond Program Advisory Committee was created by the City Council on Feb. 14, 2022, (Resolution No. 2022-37) to evaluate the City's drainage system and identify drainage improvement projects to be considered for a Bond Referendum.

The 19 members drainage bond Committee appointed by the City Council consists of the representatives from the residents, City Council, Planning and Zoning Commission, Pearland Economic Development Corporation, Independent School Districts, Alvin & Pearland, and Pearland Chamber of Commerce.

The Drainage Advisory Committee held its biweekly meeting from March 23, 2022 to June 1, 2022, at various city facilities.

Discussion and input regarding the City's 16th Community Development Block Grant (CDBG) Program - FY 2023 Annual Action Plan, as part of its FY 2013-2027 CDBG 5-Year Consolidated Plan (HUD Program Years 2022 - 2026) was also part of the meeting.

Title I of the Housing & Urban Development (HUD) Act of 1974 constitutes the basis for delivering federal community development and housing funds to local communities, primarily to address one of the three HUD National Objectives, which include: eligible assistance to low-moderate income residents; reducing slum and blight; and/or meeting local urgent needs (major catastrophe/disaster).

Every five years, the City must develop, submit to HUD for approval, and implement a Consolidated Plan that details the types of projects and activities that can address HUD National Objectives, impacting local conditions facing low-moderate income households. In addition, an Annual Action Plan is submitted to HUD for the purpose of establishing specific annual spending plans that meet the objectives of the 5-year Consolidated Plan.

Since 2006, the City has received this annual funding from the U.S. Department of Housing & Urban Development (HUD), administered each fiscal year as part of the Community Development Block Grant (CDBG) program. Cumulatively having delivered \$6,066,020 to Pearland, the CDBG program utilizes a formula method of distribution to determine its allocation of CDBG funding to eligible communities, which considers a locality's poverty rate, population, and housing conditions in determining the amount of the allocation each year.

As a result, the City has received anywhere from its lowest Annual Action Plan Allocation in \$254,426 in 2008 to its most recent 2022 allocation of \$462,666. The allocation can grow each year, which seems to take place incrementally as formulaic components change annually for the City (population, local income levels, available housing stock, affordability, etc.). HUD has recently provided the City with its allocation for FY 2023, which is \$478,854, demonstrative of the upward trend in allocations amounts each year.

One of the most basic rules involving the use of CDBG funds is that 15 percent can be used for social/public service activities, 20

percent for program administration, and there are no caps on how much of an annual allocation can be used on infrastructure and/or public facility improvements. Others include compliance with 24 CFR 570 and all of its subchapters, subparts, and sections/subsections, and the restriction that funds must be spent to serve low-moderate income individuals/households. At least 70 percent of all annual allocation amounts must go to serving low-moderate income individuals/households, and area-benefit projects must be located in areas that are comprised of 51% or more low-moderate income (census block groups, service areas, etc.).

No CDBG funds can be spent to serve individuals and/or households outside the Entitlement Jurisdiction, so these funds are restricted to the boundaries of the City of Pearland.

An important purpose of the 5-Year Consolidated Plan process is to gauge the program's ability to address future unmet needs with allocated resources during that time. Based on the FY 2023 allocation from HUD, officials report the City should expect to receive approximately \$2.1 million over the course of the five years included in the next Consolidated Plan (City of Pearland FY 2023 - 2027).

A public hearing is scheduled for the Council meeting on July 25 where more specific details will be provided and actual spending plans will be shared.

In other topics addressed during the meeting, Mayor Kevin Cole introduced new City Secretary Frances Aguilar who started her new job the day of the meeting on July 11. She comes to the City of Pearland from the City of Angleton.

Emergency team completes high water training

The Pearland Office of Emergency Management prepared employees amidst hurricane season in a two-day High-Water Response Training to heighten emergency response capabilities.

"We want our residents to know that we take their safety seriously and that we train to maintain proficiency," Emergency Management Planner Mellanee Roberts said. "There are many different hazards in flood water, and we must be prepared to address all of them."

The exercise consisted of policy and procedure review, as well as rescue and transportation drills on May 25. The drills consisted of high-water teams driving through repetitive loss areas with high-water vehicles designed to drive in flooded areas and transport people and equipment.

On June 6, the full-scale exercise required high-water response teams simulate the evacuation of residents and their pets from flooded areas and move them to pre-determined Collection Points.

Arriving from several city departments, 86 staff members participated in the exercises, including staff from the Office of Emergency Management, Police department, Fire Department, Public Works Department, Parks & Recreation, Animal Services, Communications, IT, and volunteers from the Citizens Police Academy.

To prepare for the trainings, several departments spent three months planning the drills and exercises to ensure the rescue teams can mitigate these emergencies in a safe and efficient manner.

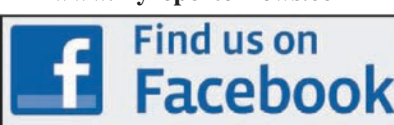
New Life Lutheran Church Fellowship Hall is located at 3521 E. Orange St. in Pearland.

ON RECREATION

"What do workers gain from their toil? 10 I have seen the burden God has laid on the human race. 11 He has made everything beautiful in its time. He has also set eternity in the human heart; yet no one can fathom what God has done from beginning to end. 12 I know that there is nothing better for people than to be happy and to do good while they live. 13 That each of them may eat and drink and find satisfaction in all their toil—this is the gift of God." - Ecclesiastes 3:9-13

I just returned from a four-day weekend at the beach in Galveston. Spending time there is indeed a gift from God. I didn't grow up near the beach and it has taken me years to embrace the sand and salt water coupled with the breeze and the burning sun in a welcoming way! But... I did. Again. I'd not been to the beach since Summer 2019. It felt good... especially being able to take a break from the hard and difficult work of being retired... and all... being with family in a very casual way made it all worth-

while. I've long believed that work is a curse (*see the opening chapters of Genesis*) but in God's design for life there is always a command to 're-create'! We do it daily. We work and play and rest. We are commanded to exercise a 'sabbath' each week...a day of rest...dedicated to worship and a personal focus on God...and as the writer of Ecclesiastes has taught us...there is a time for everything...including seasons for work and rest ...

But... in the big scheme of things I think re-creation is much more of an attitude than it is a day or a weekend... an attitude that has power for us when it gets built into our daily routines in order to impact our working and serving in a positive way. Too much work makes any of us a work-a-holic. Too much worship turns any of us into a fanatic and too much play or rest makes for a world where little is accomplished. See how smart God is? To give us each a personal template that compliments corporate life using these three key ingredients? Work, play and rest? Pretty smart for sure... as if we all just focused on one or two and not all three ... our quality of life would be diminished in a dramatic way.

So, what is my take-away from a weekend at the beach? It's great to have a change of scenery... It's wonderful to be with family and be able to play with grandchildren outside my home...I was reminded very quickly of how blessed I am as for thousands of years people who lived by the shore did so not to frolic in the sand and waves but to have access to food and transportation from one coastline village to another...and the time away offered me some 'dis-connect' from daily routines and provided some re-newed energy to address projects I'm working on still.

Jesus modeled this for us... going off alone to re-create... to pray and look inside his own heart and invited his disciples to do the same. Faith matters!

And yeah... it's hot out there... so be smart... Drink lots of water and take a break this Summer as recreation is indeed God's gift for each of us!

Pearland ISD free, reduced-price meal applications available for 2022-23

Pearland Independent School District is accepting applications for free and reduced-price meals for the 2022-23 school year.

Meals are served under the National School Lunch Program and Breakfast Program.

Online applications may be accessed now at www.school-cafe.com.

Paper applications are available at the Food Service Office (1928 N. Main). To have a paper application mailed, call 281-412-1244.

Anyone interested in reviewing Pearland ISD's free and reduced-price meal policy may visit the Food Service Office.

Criteria for Free and Reduced-Price Meal Benefits

The following criteria will be used to determine a child's eligibility for free or reduced-price meal benefits:

Income: Household income that is at or below the income eligibility levels

Categorical or Automatic Eligibility: Household receiving Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) or Food Distribution Program on Indian Reservations (FDPIR)

Program Participant: Child's status as a foster child, homeless, runaway, migrant or displaced by a declared disaster or child's enrollment in Head Start or Even Start

Income Eligibility

For those households that qualify for free or reduced-price meals based on income, an adult in the household must fill out a free and reduced-price meal application online or submit a paper application to the Food Service Office (1928 N. Main) or to their child's campus.

Those individuals filling out the application must provide the following information:

Names of all household members

Amount, frequency and source of current income for each household member

Last four digits of the Social Security number of the adult household member who signs the application (if the adult does not have a Social Security number, check the box for "NO SSN")

Signature of an adult household member attesting that the information provided is correct

Categorical or Program Eligibility

Pearland ISD works with local agencies to identify all children who are categorically and program eligible.

The Food Service Department will notify the households of these children that they do not need to complete an application.

Any household that wishes to decline benefits should contact the Food Service Office at 281-412-1244.

Applications may be submitted anytime during the school year. The information households provide on the application will be used for determining eligibility. Applications may also be verified by the school officials at any time during the school year.

Determining Eligibility

Under the provisions of the free and reduced-price meal policy, a food service clerk will review applications and determine eligibility.

Households or guardians dissatisfied with the reviewing official's eligibility determination may wish to discuss the decision with the reviewing official on an informal basis.

Households wishing to make a formal appeal for a hearing on the decision may make a request either orally or in writing to Mr. David Moody, Deputy Superintendent, at 281-485-3203 or at 1928 N. Main.

Dawson's gridiron warriors to challenge for district title

It has been four years since Dawson head coach Mike Allison took over the helm of the Dawson football fortunes, and he has certainly continued the foundation that was laid when the school opened in 2007 with former head coach Eric Wells in charge.

Coach Allison was a part of the beginning for the Eagles as the defensive coordinator, so he was no stranger to Dawson upon returning to the Eagles after a short absence for three-years as the head coach at Clear Brook High School.

This will be the fifth year for coach Allison after posting a 34-12 record for his first four years while also advancing to the area round of the playoffs all four seasons.

Coach Allison is always the first to give credit to his players and dedicated coaching staff regarding their accomplishments. The players and coaches know how to get along with one another which is a great asset when transferring information to young high school players.

The Eagles have always been a team that will be highly competitive no matter who they are playing. While they may play a team with more talent, Dawson will never be out coached which stood true with former head coach Eric Wells and now, with coach Allison and his staff.

The Eagles will have a strong non-district schedule as the Eagles will play the Hightower Hurricanes (11-3), the Klein Collins Tigers (6-5), and the Tomball Cougars (11-4). These three teams were a combined 28-12 in 2021 with Tomball advancing to the 6A DII state semifinals. This schedule will prepare Dawson for

district competition.

Looking forward to the 2022 football season, Dawson returns six offensive and seven defensive starters with 30 returning lettermen on a team that was 8-40 last season while advancing to the 6A DII area round.

Dawson is a pre-season pick to finish second in District 23-6A behind Shadow Creek, but they were a pre-season pick to finish third in 2020, but they went undefeated in league play to win the district championship. They have captured the league title the past two out of three years.

Offensively, the Eagles should be experi-

enced with a wealth of talent starting with three-year starting quarterback senior Colin Johnson who was 143-of-243 passing for 2,044 yards, 17 TDs and only 2 INTs last season. Johnson also rushed for a pair of touchdowns. While he has a strong arm through the airways, Dawson would really benefit Johnson's ability to also run the ball when that would be a better option to keep drives alive making him a dual threat on offense.

Another big-time player is junior running back Bryce Burgess who was named the district's "Offensive Newcomer of the Year" last year after rushing for 1,423 yards on 190 carries for 16 TDs while catching nine passes for 79 yards and two scores. Burgess is a threat to score every time he carries the ball.

Other players that will give Dawson an explosive offense are OL Grant Petru (6-2, 275), TE Charles Anderson (6-6, 225), RB/LB Jeremiah Treadway (5-9, 170), and OL David Escobedo.

Defensively, the Eagles should be strong, especially at the beginning of the season. Leading the way for Dawson will be LB Jackson Cody (6-1, 220) who had 88 tackles, 15 stops for loss, 3 sacks, and 1 INT. DL Chris Herpin (6-1, 305) will also be a force on that side of the ball.

Other standout players include: DL Edward Smith (6-6, 230), DB Max Menendez (5-10, 165), and DB Bryson Burness.

Pre-season prediction for District 23-6: Shadow Creek is a pre-season pick to capture the league crown again followed by Dawson, Pearland, Strake Jesuit, Alief Taylor, Alvin, Alief Hastings, and Alief Elsik.

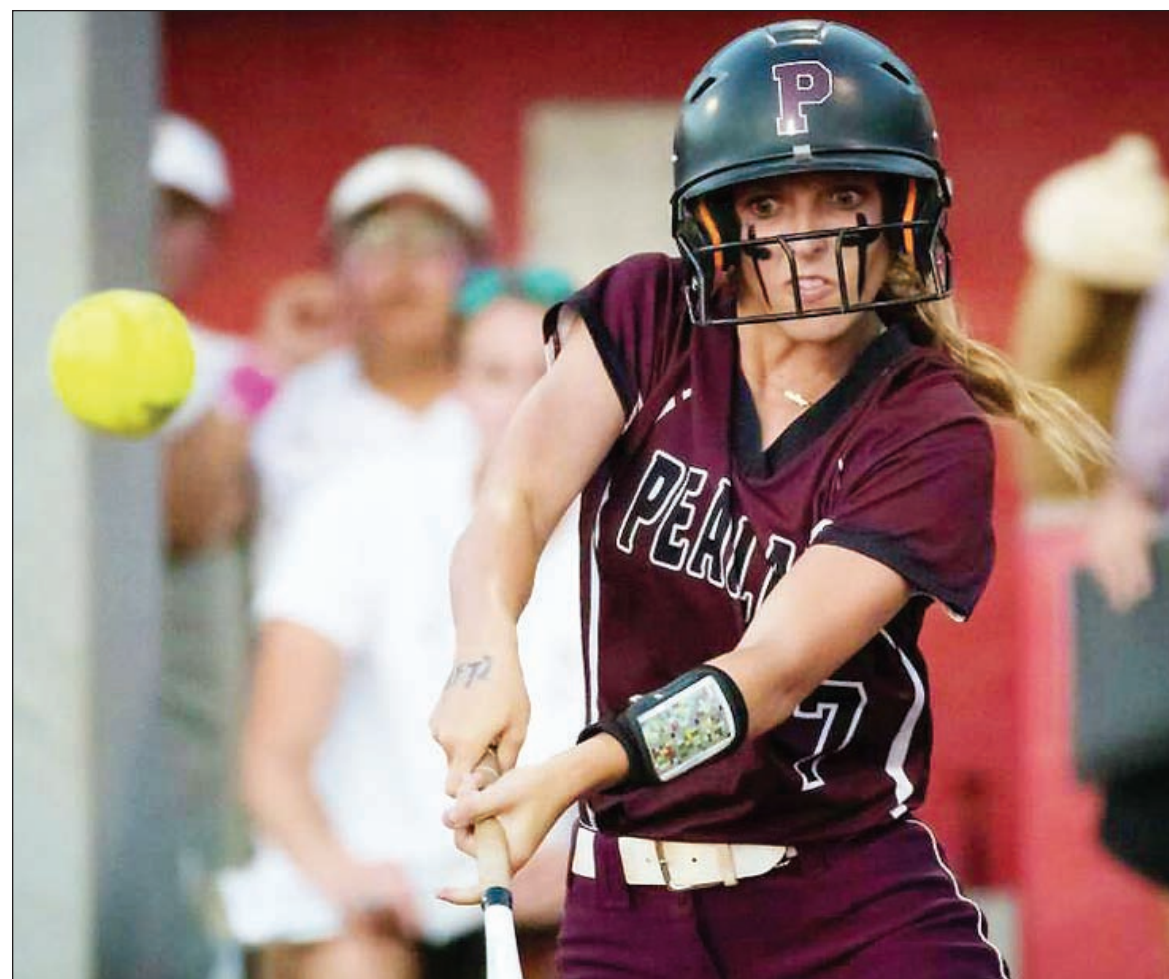
Golden, Drafton named to TSWA All-State teams



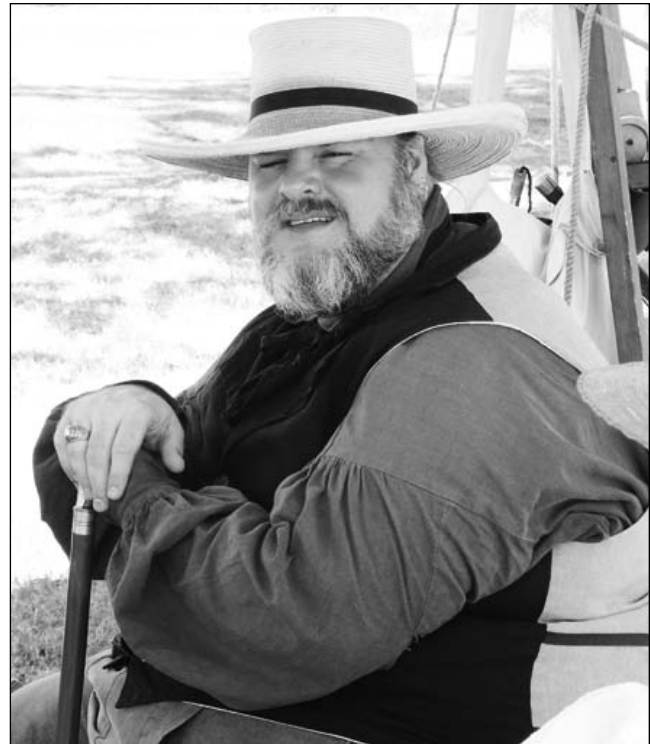
