Friendswood Rotary Club raises \$4,680 in inaugural 12x12 Art Auction

The Friendswood Rotary Club completed its inaugural 12X12 Art Auction on Dec. 9 which raised \$4,680 to fund fine arts grants in Friendswood ISD (FISD) through the Friendswood ISD Education Foundation (FEF).

The goal of the project was to feature the gifts of the artists of today while investing in the artists of tomorrow in the Friendswood community.

"We owe a huge thank you to the Conroe Art League for helping us get this project off the ground," Friendswood Rotarian Dr. Rebecca Hillenburg said.

Thirty-six participating artists, including seven Friendswood High School art students and four FISD art teachers, donated their time and talent to create a 12X12 canvas for the online auction.

"Our goal was to raise \$3,600, so we were very excited to surpass that with the strong response from the community," Friendswood

Frame & Gallery Owner and Rotarian Luis Briones said.

Friendswood Rotary President and FEF Director Judy Wiggins worked alongside Rotarian and FEF Executive Director Ashley Adair to develop a recommendation of which fine arts grants to fund with the \$4,680 raised.

"It was important to us to fund a variety of fine arts grants at both the elementary and secondary levels," Wiggins said. "We also selected a few grants that will equip students to engage in art service projects in the community as they exemplified Rotary's motto of service above self."

In total, 13 fine arts grants were selected that will impact art, music and theater projects.

One grant titled "Mo Willems Musical" for Westwood Elementary will enable all Westwood students to take a field trip to Main Street Theater to see one of their favorite books, "Don't Let The Pigeon Drive The

Bus!", come to life as a musical. The grant will promote literacy and introduce students to the art of musicals at the same time.

Another grant titled "Artwork Sew Perfect" for FHS will fund a sewing machine and materials for art students who want to engage in more three-dimensional pieces of art. This is an area students have expressed interest in exploring more in order to participate in 3D categories in art competitions and community events.

"We are so grateful to collaborate with Rotary on this new fundraiser," Adair said. "I loved visiting with the winner of each art piece at pick-up and hearing their unique 'why' behind their decision to support the project."

BAKFISH Brewing to brew no more

Dec. 31 will not only mark the end of the year, but the end of Pearland's first brewery as well.

BAKFISH Brewing Company announced they will be permanently closing at the end of the year in an open letter from co-owner Kris Szecsy. "COVID hit us hard. The current inflation is taking its toll on us as well. We don't see people coming out like they used to."

Straddling the border of Pearland and Friendswood, BAKFISH first opened its

doors in 2016. The brewery was previously home to a Sunbelt equipment rental facility before being converted to a taproom with covered patio.

In recent years you could also find BAKFISH beers in bars and retail locations throughout the Houston area including Specs, Total Wine, and Kroger. Popular brews like Defying Gravity, Cheap Sunglasses, and All Y'all Golden Ale could be found as far as Angleton and Galveston, but the rising costs of ingredients and increased competition in a saturated market have taken their toll.

"We have no regrets in this adventure that

we have been on. Very few people get to say that they got a chance to live their dream," said Szecsy. "We made it almost 7 years and I am proud of that. We have had some of the best employees and have made some friends that I expect to last a lifetime."

BAKFISH will be open and offering all beers at \$5 per glass until they run out. Although their last official day will be December 31st they may continue a few more days with a skeleton crew to get rid of any remaining inventory.

Merchandise will also be sold at a 25% discount until sold out.

Tickets are \$35 for Chamber members and \$40 for prospective members, and sponsorships begin at \$100 and run through the industrial level at \$800.

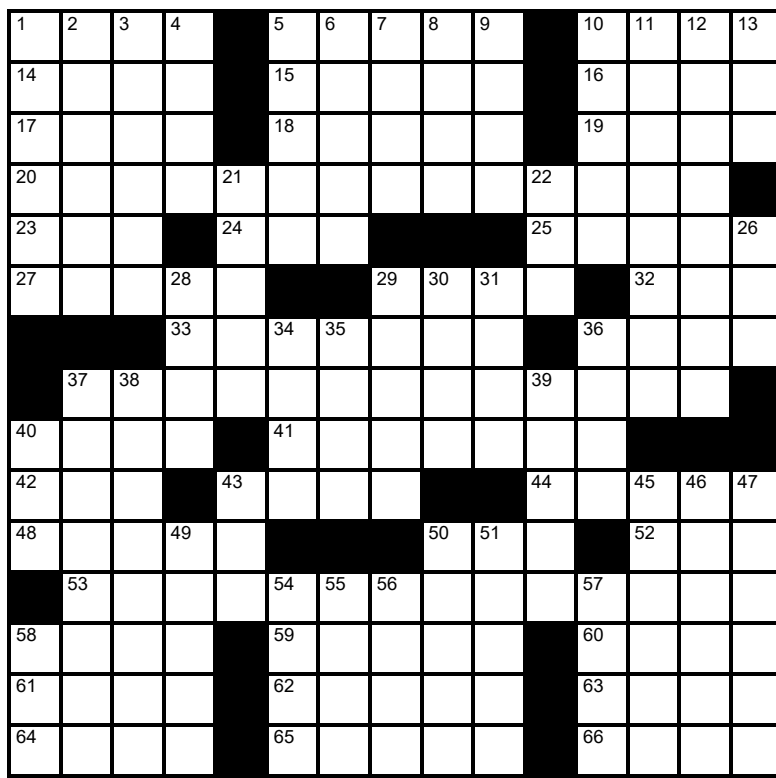

Volunteers, trees needed for Dunes Day

Volunteers are being recruited for an annual Christmas tree recycling effort designed to protect Brazoria County beaches.

"Dune's Day" will be held Jan. 21 and volunteers are needed to help stake down the recycled trees on area beaches to help rebuild dunes. The effort also keeps hundreds of trees out of the landfills each year.

The natural process of a sand dune cycles between "build-up" in between storms and erosion during storm years.

Securing recycled holiday trees on the beaches supports the onset of the building process and act as "sand-fencing" and aids in sand accumulation. Once the trees start to decompose, they act as fertilizer for dune-stabilizing grasses to grow and continue the process.

The Texas coast erodes an average of more than four feet per year, and sand dunes play a vital role in protecting the coast by acting as the first line of defense against storm-surge flooding and beach erosion.

The 2023 Dunes Day begins at 9 a.m. Jan. 21 Stahlman Park in Surfside Beach. Stahlman Park is located at 2211 Bluewater Highway.

The need for volunteers and recycled Christmas trees is imperative for this project, according to Lead Interpretive Ranger Mike Mullenweg.

Eight donation sites for trees have been set up throughout the county, and Mullenweg

encourages those who want to help to set up tree drives through social clubs, scout troops, churches and schools.

Unbound Now Houston halfway to year end goal

Unbound Now Houston reports it is over half-way to their end of year goal of \$150,000 and thank everyone who has made a gift to continue fighting human trafficking in The Greater Houston Area.

Unbound Now supports survivors and resources the Friendswood/Pearland as well as the Greater Houston communities to fight human trafficking in three primary ways: prevention and awareness, professional training, and survivor advocacy.

Survivor Advocacy is one of three primary lanes in which Unbound Now Houston runs to fight human trafficking. Unbound Advocates operate a 24/7 Crisis Hotline, providing immediate response and on-going case management to survivors of trafficking. Advocates walk alongside survivors to support them in achieving their own goals and overcoming unique challenges.

This year, Unbound Now Houston was unanimously selected in Brazoria and Galveston Counties to be the first responding advocate agency to meet survivors in crisis. When they receive a crisis call, an Unbound Advocate will continue to be onsite within 90 minutes.

The distance from the northern border of Harris County to the southern edge of Galveston Island is approximately 99 miles. Unbound Advocates will drive the 99 miles to be with the one survivor at any hour the call comes in, even in the middle of the night.

Unbound Now Houston is the local office of Unbound Now. Their offices spread across Texas, the United States, and the world.

The 2022 \$5k matching sponsors included Pinnacle, the Lanier Law Firm, Bayou City Lumber, Terry and Shari Hill as well as anonymous donors.

This holiday season, Unbound Now is looking back at how HOPE has motivated us through all the years. Unbound Now developed four Principles of Trauma-Informed Care to help protect survivors in healing.

HOPE stands for the following:

1. Help create space for survivors to experience physical and emotional safety.
2. Offer connection and relationship. Meet survivors where they are and go at their pace.
3. Practice cultural humility regarding race, ethnicity, gender, or background to help build trust.
4. Empower survivors, through a strength-based

approach, to make good choices for their lives by promoting resiliency, coping skills, and self-regulation.

Complex trauma happens in the context of relationship, and therefore, healthy relationships are required to heal from it. This is the primary role of our advocates, who serve survivors 24/7, across the Greater Houston Area. Advocates quite literally meet survivors where they are, driving hours each week to visit survivors and build connection over meals, birthday celebrations, graduations, and hard times. Unbound Now members are there to support them, build trust, and facilitate choices for when they are ready to make them.

On Jan. 21, they are rallying together during National Human Trafficking Prevention Month to say Not In My City. They will go through a short training, then launch out into the community together to post life-saving signage for those experiencing trafficking.

Unbound Now was founded in 2012 through Antioch Community Church in Waco, Texas. Since then, we have expanded into a network of chapters and anti-human trafficking projects around the world.

Unbound Now Houston launched in Summer 2013 out of Antioch Community Church Houston in response to the city's known reputation for human trafficking. Executive Director, Kerri Taylor, and a team of committed members volunteered their time, efforts and resources as the groundwork for a solid chapter was laid.

In the early days, meetings were held in homes and the church's office space to educate the community on the atrocities of human trafficking globally and locally. As momentum swelled, they established a presence in the community, offering trainings to civic organizations, schools and churches. Along the way, they were called to assist survivors and their families with their journey to healing.

Today, Unbound Now is recognized in the Greater Houston Area as an established partner within an impactful network of entities committed to ending human trafficking in our city. Small seeds sown in faithfulness have grown tall and strong and they are looking to the future, full of hope and expectation, for what is to come.

Museum presents 'Birth of a Navy'

The Brazoria County Historical Museum will host "Birth of a Navy: God Prosper Texas! Samuel Rhoads Fisher" on Thursday, Jan. 5.

During the 6 p.m. program, Admiral Dallam Masterson, fourth great grandson of Samuel Rhoads Fisher, will recount the life of Fisher, the first Secretary of the Navy for the Republic of Texas.

Samuel Rhoads Fisher met Moses and Stephen F. Austin in Missouri in 1819 and decided to move his shipping business from Philadelphia to Austin's colony. He was instrumental in creating the Texas Navy, beginning with the acquisition of the first Navy schooner William Robbins (renamed Liberty) that captured Mexican supplies and diverted them to the Texian army to ensure their victory at San Jacinto.

Fisher signed the Texas Declaration of Independence and was appointed the first Secretary of the Navy for the Republic of Texas. When Mexico threatened the survival of the young Republic with a naval blockade of the Texas coast in 1837, Secretary Fisher ordered the Texas Navy on a diversionary cruise to Yucatán that broke the blockade. President Houston was not pleased that Fisher volunteered for the Yucatán cruise while on leave and fired him when he returned to a hero's welcome. Fisher was cleared of all Houston's charges by the Texas Senate, and in his farewell letter Fisher closed with "God prosper Texas! and to you my friends and fellow citizens, happiness and thanks."

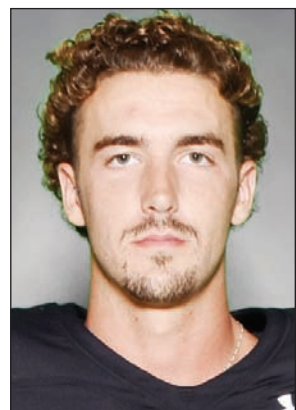

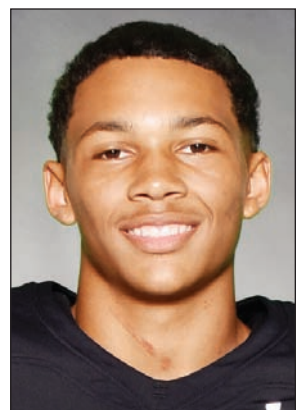
