## Friendswood in Top 50 of Safest Cities in America

Friendswood ranks in the top 50 safest cities in America according to NeighborhoodScout. The company recently released its 2023 Top 100 Safest Cities in the US report.

Friendswood ranked as number 50. Cities in Texas that were also in the top 50 include Fulshear (6), Colleyville (21), Little Elm (34), Wylie (37), Keller (45), and Prosper (48). In the top 100 in Texas, Flower Mound (57) is followed with Hutto (88).

Data used for this research are 1) the number of total crimes reported to the FBI to have occurred in each city, and 2) the population of each city. Their research reveals the 100 safest cities in America with 25,000 or more people, based on the total number of property and violent crimes per 1,000 residents. Crimes include burglary, larceny-theft, motor vehicle theft, murder, rape, armed robbery, and aggravated assault. Data used for this research are 1) the number of total crimes reported to the FBI to have occurred in each city, and 2) the

population of each city.

They report that based on the latest national data available at the time of publication, representing calendar year 2021 and released in October 2022, this report reveals interesting patterns about safety from crime in America.

Friendswood was reported with a population of 41,004 and a total crime rate (per 1,000 residents) of 6.5. Chance of being a victim was reported as 1 in 152.

Gabriel, 28, is a model, clothing designer and sewing instructor. She previously won Miss Texas and Miss USA, making her the first Filopena-American to not only win the Miss USA contest but also to win both Miss USA and Miss Universe.

The 71st Miss Universe pageant reports that the US and Venezuela are the top countries with the most Miss Universe wins. Gabriel from the US won this year with Miss Venezuela, Amanda Dudamel, as runner-up.

Her Miss Universe bio reports that Gabriel has a degree in fashion design from North Texas University in Denton. She started her own company with her own eco-clothing line, R'Bonney Nola. In the Miss USA competition, she wore some of her own designs.

During the event she wore a tribute to NASA located near Friendswood with an elaborate space themed outfit. The silver glit-

tering attire was equipped with an American flag, moon and stars. Another memorable outfit was one made of recycled plastic containers made into a red cape that bore the words "if not now, then when?" The cape was worn in the swimsuit competition of the contest.

Ironically, the 28-year-old is at the age that is the oldest a contestant can be in the Miss Universe pageant. To do this, she had to do it 'now' but she shared with judges that she believes age does not define women. She advocated the pageant raise the age limit.

Gabriel not only designs for her clothing line but also works as a sewing teacher for women who have survived human trafficking, domestic violence and trauma. She was able to share about her work during the final stage of the competition. She shared that she wants to be a part in transforming their lives as well as use her skills as a vehicle for change.

As part of her winning the Miss Universe contest, she will be spending a year traveling around the world representing the Miss Universe organization.

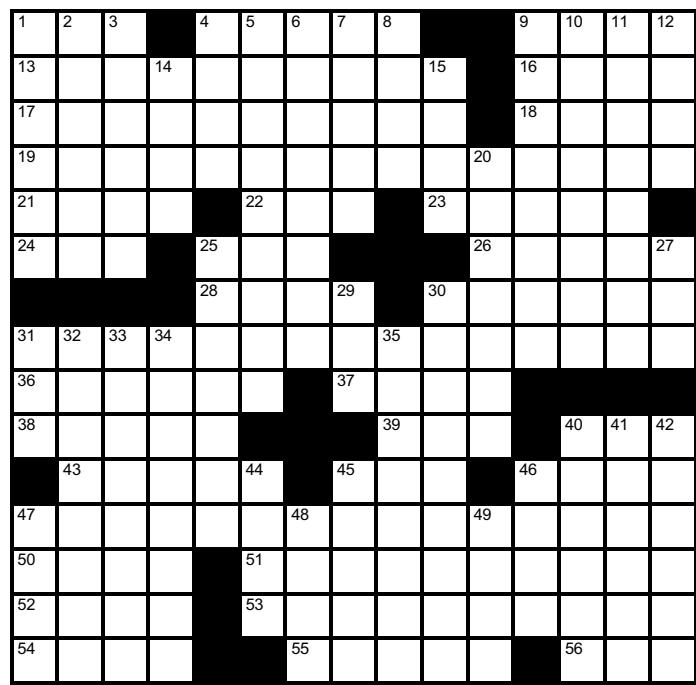

*"If we say we have no sin, we deceive ourselves and the truth is not in us. but if we confess our sins, God who is faithful and just will forgive us our sins and cleanse us from all unrighteousness."*

— I John 1:8-9

This past Monday our country celebrated Martin Luther King, Jr. Day. Parades were held, speeches were given... honor rose up all over the country! Dr. King was a voice for 'freedom' and a voice for 'truth.' He knew not just the story of Jesus but the Savior himself. His preaching was powerful, passionate and prophetic... putting his faith and life on the line every day of his public ministry. Many people loved him for this. Some didn't and they killed him for it.

Dr. King was 39 years old when he was shot dead on a hotel balcony in Memphis, TN and people remember him for not only what he said... but also for what he did and that was to bring attention to the great sin of racial injustice and the nation's bigotry toward the black people who live here. Cullier, a 6-2 sophomore forward, scored six points in the first quarter and added seven more points in the second period which gave him 13 points in the first half.

## No. 11 state-ranked Lady Oilers remain unbeaten in district play

The Pearland Lady Oilers (23-4) concluded the first round of District 23-6A action with wins over Dawson (50-40) and Alief Taylor (54-34) to remain perfect at 6-0. The No. 11 state-ranked Lady Oilers were only challenged by Shadow Creek who pressed the Lady Oilers to double overtime before Pearland pulled out the win.

When Pearland traveled to face Dawson (14-14, 3-3), the Lady Oilers found themselves facing a much-improved Lady Eagles squad who gave an all-out effort for the entire game.

Pearland led from start to finish and built an 18-point fourth-quarter lead before a late push from the Lady Eagles narrowed the final score to 50-40.

"There's a lot of antsiness that comes with a rivalry game," Pearland head coach Jere Adams said.

"We started a little slow but maintained our composure for the first 3 quarters. I was pleased with the effort, but we have to minimize the turnovers."

Pearland senior guard Janae Tucker fired in a 3-pointer at the end of the first quarter to give Pearland a 14-8 lead. The Lady Oilers began the second quarter with an 8-1 run for a 22-9 advantage. Pearland would finish with a 27-14 lead at intermission.

"It's tough when your two leading scorers don't score in the first half," Dawson head coach Sharee Griffin said. "We came out hard in the second half, but it wasn't enough."

"Pearland is super-fast. (Paige Bonner) is an amazing defender. She's quick, aggressive and anticipates well."

"We were overthinking too much instead of just playing. Once we started attacking the basket, we got Rylee (Grays) in foul

trouble, but it was too late then."
