



# **FISD** selects 2023-2024 instructional calendar

Friendswood ISD has received Board approval for their 2023-2024 Instructional Calendar. The Friendswood ISD School Board

unanimously chose Option C out of three options for the 2023-2024 Instructional Calendar for the district. The calendar offered the staff returning

date of August 7 with six professional learning days. The first day of school for students will be Tuesday, August 15. The Fall Holiday begins with a

parent/teacher conference or PSAT day followed by a professional learning/student holiday and exchange day/student holiday.

There are also two exchange days for professional learning completed off contract. The district recommended Option C as

the one for the Board to pass since it provided a fall holiday for students and started slightly later than Option B. In B the first day of school would be August 10. District administration liked the later start due to bond projects being completed.

Option C was the middle choice by staff (32 percent) and parents (33 percent).

Option B had staff support of 44 percent

with parents at 38 percent. According to FISD, the 2023-2024 Instructional Calendar process has many steps.

Information is first gathered through various Superintendent committees made up of teachers as well as parents. Then a staff committee is formed with representation from each campus as well as district staff. This committee reviews the guiding principles as well as state requirements and develops drafts for feedback. The three drafts were first taken to all

FISD staff, presented at the December School Board meeting and parents. Based on the feedback, the drafts were modified to include one additional day for the Winter Break and replaced with an exchange Professional Development day.

All three calendars provided for 172 days of instruction which includes enough minutes for two school closure days. All three

had school ending the year by Memorial Day and had a parent/teacher conference/ PSAT day where students are not at school. The last day of school before the Christmas break for students is Thursday, Dec. 21 and students return on Tuesday, Jan. 9, 2024. All calendars have a day in

April designated for professional learning

and a day of service.

# FISD to have walk zones around Cline, FJH

Walk zones around Cline Elementary and Friendswood Jr High were unanimously approved at the recent meeting of the Friendswood ISD School Board.

The Texas Education Agency provides a transportation allotment for school districts providing regular route services when a student lives further than two miles from the school (TEC, §48.151).

Currently, Friendswood ISD is providing regular routes that are within two miles and is not receiving state funding. Board members were told that in recent years, it has become increasingly difficult to find bus drivers and the transportation route times have become longer as the need to double run certain areas of the district.

The district reports that the new Cline Elementary and Friendswood Junior High are both located within a neighborhood with ample sidewalks. FISD administration proposed and the board approved a walk zone of 0.5 miles around Cline Elementary and 1.0 around Friendswood Junior High.

Bus transportation will not be provided in these areas once the walk zones are used. Transportation will be provided to all students at FJH regardless of distance that live across FM 518 for safety purposes.

This will go into effect beginning with the 2023-2024 school year and will allow for the elimination of two regular routes to assist with transportation to the two new zones within the current time start times for all schools. Maps were given to board members to show the areas where transportation will no longer be provided.

The district does not know the exact number of students that will be impacted by this change next year, but they do know that there are currently 153 students registered for transportation to the current Cline campus and 133 current FJHS

### ON LOSING MY SALVATION

"But because of his great love for us, God, who is rich in mercy, 5 made us alive with Christ even when we were dead in our sins-it is by grace you have been saved. 6 And God raised us up with Christ and seated us with him in the heavenly realms in Christ Jesus; 8For it is by grace you have been saved, through faith—and this is not from yourselves, it is the gift of God— 9 not by works, so that no one can boast... 10 being God's handiwork, created in Christ Jesus to do good works, which God prepared in advance for us to do." -Ephesians 2: 4-6, 8-10

I've been lost before. I've lost my car keys. I've lost my wallet. I've lost days of work due to illness or neglect... but I can never lose my salvation. Word. I was leading an adult Bible class this past Sunday and we

were talking about Jesus' baptism in the Jordan River by his cousin John and how Christian baptism came to be and how the promises given to anyone who is baptized includes being connected to one another in holy, wonderful and mysterious ways. And in that conversation... there were twists and turns and thoughts of faith, salvation and eternity including big church words like justification and sanctification and honest concerns about who's in and who's out and by the time we got to the end of our discussion time... the question was asked by a sincere person in a sincere way... "can we lose our salvation?" It's a good question to ask... and I'm glad it was... as we're not alone in the asking and it's a query which goes back to the beginning of time...

And just so everyone remembers... I've been a Christian all my life... even though I've searched for a better way than following Jesus... and tried more than once to walk away from it all due to selfish and short-sighted thoughts... and that I'm also part of the 'Lutheran' tribe of Christians who can sincerely say Martin Luther wrestled with this question like so many before and after his life. How about you? Can you lose your salvation? Faith matters... for all of us and God!

In addition to being of the 'Lutheran' tribe I'm one who is

firmly camped out in the "salvation is a gift of God" clan and am ready to die on that hill... until someone can show me a better way... and it's like this... as I echo St. Paul's words to his friends in Ephesus... by grace I have been saved... this is God's own doing... a gift I didn't ask for or frankly deserve... just like... I didn't ask to be here in this world... my parents loved each other enough that they took a risk of having a son... me... and then went so far as to take care of me and nurture me until I could get out on my own... and again... I didn't ask to be here... but here I am... almost 69 years later still amazed at how that all happened yet pondering still what's down the road.... # PISD pursuing afterschool grants

#### Lawhon, Harris programs would be no cost to parents

By N. BRADFORD Reporter News Staff

A partnership with the Boys and Girls Club of Brazoria County could provide free after school activities at C.J. Harris Elemen-

tary in addition to programs already offered at Lawhon Elementary next fall. "Lawhon is a renewal of the process, and C. J. Harris is an add," Superintendent

Larry Berger said. Pearland ISD trustees on Jan. 17 unanimously authorized a letter of support to the Texas Education Agency to move forward with the Nita M. Lowery 21st Century Community Learning Centers grant.

The grant-funded programs will be added to the school district's mix of offerings for students after school. Programs at other campuses are provided through a Communities in

Schools of Brazoria County grant at a cost of \$15,000 per year. Through the Boys and

Girls club, programming would be offered at both Lawhon and Harris free of charge to the district and parents. "We are reviewing all our

programs as part of our district initiatives and goals to maximize funds to support our students' needs," Berger told the board.

In the current school year at Harris, the district partners with the YMCA to provide after-school activities at Harris Elementary, but at a cost to parents. As part of the proposed agreement, Pearland ISD will provide in-kind contributions such as campus and facility use, janitorial services, referrals and internet service.

The board also discussed afterschool programing at

Junior High South.

"Part of the issue when you get to the junior high level is the competition with sports, athletics and fine arts," Berger said. "Afterschool programming doesn't necessarily work at the junior high."

Also on Jan. 17, the school board voted to add a position at Carleston Ele-

"We have had increased enrollment, which is good,

but increased enrollment has some side effects late in the school year," Berger said.

Kindergarten enrollment at the campus has continued to increase, he said.

Since dividing classrooms late in the year is not welcome by parents, students or staff, the district opted to add a paraprofessional position to assist with the current three classes of kindergartners.

Dawson sits atop the league standings at 7-0 after beating Alvin, 108-47, Saturday.

Alief Taylor, Shadow Creek and Strake Jesuit are each tied for second at 5-2 after the Crusaders edged Shadow Creek, 58-57, Saturday.

Pearland is 10-13 overall and 3-4 in the league standings. "It's one game at a time with us," Buckelew said. "We'll try to start chipping away and see if we can score enough points to get us into the playoffs. We control our own destiny by winning the games, but there are good teams ahead of us. A lot our kids aren't varsity-ready, but we're getting there. I like our chances.'

# FEF awards over \$46,000 at Legacy Grant SurPrize Patrol

The Friendswood ISD Education Foundation (FEF) recently awarded FISD with more than \$46,000 in grants during its inaugural Legacy Grant SurPrize Patrol.

FEF launched the Legacy Grant Program for the 2022-2023 school year in response to an increasing demand for grants that go beyond the \$5,000 threshold set by the Adopt-a-Grant program. Per FEF's updated Investment Policy Statement, 3% of FEF"S endowment fund will be pulled each year to fund Legacy Grants. The endowment currently sits around \$1.5 million and continues to grow with the support of FEF's Century Club

According to FEF Grant Committee Chair Kelly Lovell, the team had no idea how many applications to expect in the inaugural

"We were blown away when we received 15 grants totaling more than \$200,000," Lovell said. "Each grant was worthy of funding which made the committee's job

very challenging." After reviewing the submissions, seven

applicants were invited to present their projects in person and answer questions. Of those that presented, three were selected for funding and those teachers were informed with a surprise visit from FEF and the Friendswood High School (FHS) drumline on Dec. 14.

Grant recipients include Westwood Media Integration Specialist Elizabeth Henning who was awarded \$8,488.99 for a book vending machine, Friendswood Junior High Robotics Teacher PJ Givens who was awarded \$23,700.00 to fund the Robotics Vex IQ Classroom and FHS Art Teacher Mandy Harris who was awarded \$13,994.65 to start a ceramics program at FHS.

"I can not thank the Education Foundation enough for letting us dream for our art students at FHS," Harris said. "This gift of a ceramics program for our students is something I have dreamed of for years." Givens shared that after working in FISD

for 23 years, it never ceases to amaze him how much support is received from the parents and community of Friendswood. "When I was presented with the grant, I

was nothing short of shocked and speechless," Givens said. "The support of the FJH robotics program is overwhelming and will make a difference in students' lives for years
