

# FISD approves 1.5% pay increase

Friendswood Independent School District has approved a plan to grant all teachers and staff members a 1.5% pay increase. The decision is projected to lead the district into an estimated budget deficit between \$1.5 million and \$2.7 million.

Texas, was left disappointed by the lack of an increase in state education funding. Despite appeals from numerous districts and a substantial budget surplus, the state legislature concluded its session without a significant increase in education spending for the upcoming school year.

With the state legislature having concluded their session and currently no special sessions scheduled to address education funding, any potential increase in state aid will likely be delayed until the next regular session in 2024. The unanimous decision by the School Board was made in the face of increasing concerns about teacher retention and the growing financial burdens educators are experiencing across the state. The pay raise, which will add \$1,463,197 to the district budget, is intended to offer some relief to the employees of the district, despite the impending financial constraints.

This decision also comes after a lackluster Texas legislative session, where Friendswood

Although a moderate increase of \$50 per student was eventually passed, this amounts to a less than 1% increase for teacher pay.

The 1.5% pay raise will result in a significant expense for Friendswood ISD, contributing to the projected budget deficit for the 2023-2024 school year. Despite these financial challenges, district leaders felt it was an essential step to support their staff and maintain a high standard of education for their students.

Under Texas law, school districts must pass a budget no later than the end of August.

## FHS roof collapse caused by omission

High School during its renovation has been attributed to an omission in the demolition plans.

"The roof collapsed following the removal of a load-bearing wall that was supporting the roof and which had not been identified as a load-bearing wall in the demolition plans," stated Superintendent Thad Roher.

Following the incident, the Occupational Safety and Health Administration (OSHA) conducted an investigation, after which it "released

Roher concluded his letter by stating, "Our top priority is to create a safe and secure learning environment for all students, teachers, and staff members and to end with amazing facilities to serve the deserving students, staff, and community of FISD. Once again, we ask for your grace, space, and understanding during this vear."

## County OKs drainage study

Brazoria County Commissioners on June 27 approved a drainage study plan contract for a large master planned developments located near Angleton.

The Ashland Development is an approximately 2,500-lot community expected to bring thousands of new residents to the Angleton area.

The \$90,000 drainage plan and study review contract was awarded to Freese and Nichols Inc. These funds will be reimbursed by the developer.

"We sat down with Freese and Nichols when we asked for this proposal and told them some of our overarching concerns -- we wanted them to compare this to the model they created for the Brazos River flood event," County Engineer Matthew Hanks told commissioners. "We know there's a lot of water headed to this piece of property when a flood occurs."

# **TWA honors** Lady Oilers

The accolades continue to honor Pearland head softball coach Laneigh Clark and some of the Lady Oilers after winning the 2023 Class 6A state softball championship.

Clark as been name 6A "Coach of the Year" by the Texas Sports Writers Association after the Lady O's posted a 41-3 season record while claiming the 6A state title with a 4-2 win over Denton Guyer.

Clark is the winningest 6A coach in Texas and the second winningest softball coach of any class in the Lone Star State. Clark has a career record of 794-461-8 while posting a 688-227-5 mark at Pearland from 1999 to 2023.

The veteran Hall-of-Fame coach was also named the 2023 Texas High School Coaches Association "Coach of the Year." Clark was recognized for her outstanding coaching career when she was inducted into the Texas Girls Coaches Association Hall of Fame in 2021.

Pearland senior pitcher Abigail Gutierrez was named "Player of the Year" by the TSWA. The UT-Arlington signee won both games at the state tournament as the Lady Oilers beat San Benito 3-2 in the state semifinal game and knocked off Denton Guyer 4-2 in the state title game.

The first-team All-State selection posted a 26-1 pitching record with 145.3 innings, 1.39 earned run average, 191 strikeouts, and 36 walks.

Pearland senior second baseman Kennedy Drafton was named to the All-State first-team after she hit 473. BA with 6 doubles, 6 triples, 2 HR, 30 RBIs, 55 runs scored, and 28-out-of 31 stolen bases. Drafton will continue her education and playing career at Eastern Kentucky. Drafton was named to the UIL All-Tournament Team.

Named to the All-State second-team was senior centerfielder Hailey Golden who will continue her education and playing career for Texas A&M. Golden hit .509, with .698 slugging percentage, .544 OB percentage, one HR, three doubles, two triples, eight RBIs, 21 runs scored, and four walks. 1. Golden was named Most Valuable Player at the state tournament.

"But every coach always has a list of schools in their mind where, if they ever reached out or an opportunity ever presented itself, you at least have to listen. Pearland was one of those places."

Gotte is a winner, having been a part of four state champions: three as an assistant coach and offensive coordinator at Katy (2003, 2012, 2015) and one as offensive coordinator at La Marque (2006).

He played on the offensive line for the legendary Mike Johnston at Katy in the '90s, graduating in 1997. As a sophomore, Gotte helped the Tigers to the state final against Plano. He also coached under Johnston from 2001-2003 as an assistant offensive line coach and was assistant coach and offensive coordinator under Garv Joseph, who succeeded Johnston in 2004, from 2009-2016 after stints at Deer Park, La Marque, and Flower Mound Marcus.

With just a few months in Pearland, Gotte began his journey as the leader of the Oilers.

Pearland began the 2022 season with a 1-2 non-district outcome falling to Clear Falls 20-17 and C.E. King 45-7 while defeating Spring Branch Memorial 40-14. The Oilers went on to finish third in the District 23-6A race behind Shadow Creek and Dawson while advancing to the post-season for the 23rd straight vear. A 35-21 loss to Dickinson in the opening round of the playoffs ended the season at 6-5.

A very optimistic Gotte sees 2023 getting off to a much better start now that the Oilers have had a year under his guidance.

"After going through our first true off-season, it was important for us during spring football to get back to basics fundamentally (blocking and tackling), develop and grow our football understanding (IQ), while identifying what our strengths and weaknesses are with personnel," Gotte recently said.

"One of the biggest areas of need games have been close
