State of the District on Tuesday given by Friendswood ISD Superintendent Thad Roher.

Grading was a big part of the district redefining success. The move will be from traditional grades to goals and standards. "What this allows us to do is allow students to set their own goals," said Roher. The intention is to address the individual needs of the student.

At the secondary level, the district is eliminating class rank outside of the top 10%. "Students are no longer just a number," said Roher. The district also decided not to include electives in calculating a student's GPA,

choosing which classes they took.

Roher then segued into extracurricular activities such as art and robotics and health science which exemplify the district's focus on authentic learning experience. Programs such as Ready, Set, Teach and the Mustang Incubator were highlighted as examples of opportunities for students to find their passion.

Community partnerships such as the Faith Leaders, Mustang Senior Citizens, and the City of Friendswood were also a source of pride for Mr. Roher, especially as they relate to safety which has been a sensitive subject this school year in the aftermath of the Uvalde

"I hear people all the time say taxes in Friendswood are high, but it's not the taxes that are high, it's the home values." Roher also shared the tax rates of surrounding school districts to show the Friendswood ISD rate is one of the lowest.

## FHS holds ribbon-cutting ceremony for preschool run by student teachers

On Thursday, Sept. 8, Friendswood High School (FHS) held a ribbon-cutting ceremony to officially celebrate finishing construction for the Little Mustang Preschool (LMP) which will open its doors to 15 preschoolers on Oct. 4. LMP is a laboratory early childhood classroom in which FHS juniors and

seniors in the Education and Training Ready, Set, Teach Program (RST) plan, prepare and teach developmentally appropriate lessons.

There will be 16 high school student-teachers, divided into two with the guidance of RST teacher Brooke Holtvluwer. Class

will be 9am to 12pm Tuesday through Friday and each week, there will be one lead teacher and one student teacher who will be responsible for planning the activities while the other student teachers will help with one-on-one instruction, prepare snacks, plan future lessons, run drop off and pick up, etc.

After many months of construction, the preschool now has its own spacious, completely renovated classroom, newly constructed playground and its own entrance/exit into the building, making it a fun, safe learning environment for all students.

"It is exciting to see all the work come together," Holtvluwer said. "I know the first day will be a mix of emotions for my stu-

## Murder on Oak Vista Dr.

Friendswood police were dispatched Monday afternoon to a home in the 400 block of Oak Vista Drive. During a security sweep of the home they found a man lying dead in the front hall.

The Galveston County Medical Examiner's Office was called to the scene to confirm the cause of death was a head wound that appears consistent with foul play. Police also believe the attack occurred several days ago.

The name of the deceased has not yet been released as Friendswood police are still interviewing neighbors and associates. A person of

Murder in Friendswood is extremely rare, with only three cases since 2002 according to the FBI's national crime statistics. The most recent, a murder-suicide at a senior living facility, occurred in 2015.

### WILL OUR CHILDREN HAVE FAITH?

"He planted a witness in Jacob, set his Word firmly in Israel... then... commanded our parents to teach it to their children so the next generation would know, and all the generations to come— Know the truth and tell the stories so their children can trust in God, never forget the works of God but keep his commands to the letter. Heaven forbid... they should be like their parents... bullheaded and bad, a fickle and faithless bunch who never stayed true to God." – Psalm 78:5-8 (The Message)

The children and grandchildren are back in school. Some parents are excited about what they will learn. Other parents seem concerned about some of the content of what they will read, and age seems to be a factor. But... it's a big world out there... and it's been a long time since I finished the 26th grade back in 2002 and still there's something new to learn each and every day...

The Psalmist here begins this chapter with these words... "Listen, dear friends, to God's truth, bend your ears to what I tell you. I'm chewing on the morsel of a proverb..." and we all know the value of proverbs... those short statements with a long-term lesson... those gems of wisdom from an unwritten ancient guidebook which cross the boundaries of culture and language and geography... for it is what we come to know and absorb as our own which becomes good not just for us... but all those around us... as St. Paul wrote to the Corinthians... " but when completeness comes, what is in part disappears. When I was a child, I talked like a child, I thought like a child, I reasoned like a child. When I became a man, I put the ways of childhood behind me." Why? Simple. There are things that we need to know... reading, writing and arithmetic... but there other things we need to never forget like respect, honesty, compassion, generosity, and justice... those values passed on not in a textbook but by the stories and examples from one generation to the next.

Back in the day, my 3rd-grade teacher began each class with a roll call, the pledge of allegiance to the US flag, followed by a Bible story and sometimes a reading from Aesop's fables and ending with the prayer Jesus taught his disciples when they admitted they didn't know how to... the prayer we now call 'The Lord's Prayer.' That was 1963 and most schools around the country had a morning routine like that for decades prior... but that all changed with a US Supreme Court decision and in fourth grade that practice ceased.

I call this 'America's 50+ Year Experiment' from 1964-2014... now extended almost another decade and it's easy to see how life in our country is very different from the time when I rode the bus to school every day in grades 1-12! But... bend your ear and hear this... I don't think it was the public school's responsibility to teach faith to the children... rather... over the centuries it was always the parents and especially the grandparents role to share those important lessons about who we are... whose we are... where we've come from... and what we should be doing on our way to where we are going ... and so ... I am grateful to my parents for dragging me to Sunday School and attending 'catechism' classes as a teen having my infant faith 'confirmed'... something I tend to each day in daily repentance to focus my faith... and especially to my grandmother Irene for reading me Bible stories at night... at bedtime... as they remain foundational beyond the story's details unto the deeper meaning which is their design...

Will our children have faith? Yes. They will believe in something. They will... and over time they will hold within what they are taught or lack what they are not... The question is ... 'what DO we want our children to believe?' as it is in that moment, we ask ourselves about our own faith foundations for everyone's sake. Faith matters...

Alabama-Coushatta member Delvin Johnson will discuss the history and role of the tribe in Texas history during a special presentation Thursday evening at the Angleton Library, 401 East Cedar.

The 6 p.m. program is hosted by the Brazoria County Historical Museum.

Recognized as two separate tribes, the Alabamas and the Coushattas migrated west into Texas from Alabama for many reasons, eventually settling into the Big Thicket region of Spanish Texas between the Sabine and Brazos rivers. By 1809 their population totaled approximately 1,650.

Peace with their neighbors was preferred by both tribes, but when provoked they proved to be fierce and effective warriors. The Coushattas participated in the Mexican War of Independence in 1812-13 and both tribes assisted Stephen F. Austin in campaigns against the Karankawa and during the Fredonia Rebellion.



## Friendswood wins district opener over Kempner 27-7

Getting the first district win of the season is really important, especially when competing in one of the toughest leagues in the state and every game can mean the difference in making the playoffs at the end of the year.

The strength of Friendswood stepped up in a big way as the defense held the Cougars to only 130 total yards. However, 71-yards of that came on one play when Kempner scored their only touchdown in the first quarter on a short pass that turned into a 71-yard scoring jaunt. That would be the only time the Cougars would cross the pay station for the rest of the game.

Friendswood got on the scoreboard first on a 22-yard field goal for a 3-0 lead on the first possession of the game for the Mustangs.

That's when Kempner's Antonio Jacobs grabbed the short pass from QB Javon Goss for the long touchdown giv-

ing the Cougars a 7-3 lead.

"That first play they made was unbelievable, but then you just felt like they were never going to score again," Friendswood head football coach Robert Koopmann said.

The Kempner lead was short lived as Friendswood took advantage of two personal fouls by the Cougars that led to a 7-yard touchdown scamper by Jackson Rhodes with 3:01 left in the first quarter to give the Mustangs a 10-7 lead.

Friendswood would finish the first half with one more field goal as Rudolph nailed a 25-yarder for a 13-7 lead at intermission.

"When we were up 13-7 at the half, I told them that we're not going to lose this game because we're not going to let them score, but then it was just about how ugly we were going to make it on offense — and, boy, we tried to make it ugly," Koopmann said.

While both teams struggled in the third quarter, Friendswood got a two-score cushion with a 12-play, 80yard scoring drive capped off by a 1-yard scoring plunge by Rhodes at the 4:15 mark of the fourth period for a 20-7 advantage.

The Mustangs got two long plays during the drive from Hunter Smyrl who had a 27-yard catch and run while Walker Winters added a 21-yard run.

Friendswood took advantage of another Kempner miscue when linebacker Braylan Shelby recovered a fumble at the Cougar 35. Quarterback Brock Foster hit Smyrl on a fourth down pass completion covering 23-yards and the score with 25 seconds remaining in the game to put the final touches on the 27-7 win.

The Mustangs will face Manvel (1-2, 0-1) at Henry Winston Stadium on Friday, Sept. 16 at 7:00 p.m. in a crucial district showdown. Manvel lost to Angleton 24-21 in their district opener on a last second field goal.

"We've got a lot of work to do, but we're going to get to it," Koopmann said.

## **C.E. King stops Pearland 45-7 in non-district contest**

The outcome of the game between Pearland and C.E. King didn't end the way that new head coach B.J. Gotte wanted, but it was another indicator on the progress that the Oilers are making under the new coaching regime.

"I was proud of the effort the kids played with over all four quarters," Gotte said. "When you are playing a team as physically talented as CE King, it is important to match their physical intensity as well as be disciplined in our play. "The margin for error against a team like that is so small, so when you make mistakes in assignments they will make you pay."

Pearland forced King to punt on their first possession after three plays giving the Oilers good field position at their own 39, but a lost fumble on the first play gave the Panthers the ball at the Pearland 40.

It took only one play for the Panthers to score on a 40-yard dash to the end zone for a 7-0 lead with 9:45 left in the opening stanza.

After the Oilers failed to make a first down on their second possession, King set up their next drive at their own 23.

One play later, the Panthers scored on a 77-yard pass from QB Denim Johnson to WR Rae'G Dailey with 8:13 left in

the first quarter making the score 14-0.

While Pearland was struggling against the King defense, the Panthers closed out the first half with two more scores for a 28-0 lead at intermission.

It was more of the same in the second half as King built a 42-0 lead with 3:26 left in the third quarter.

Pearland finally got on the scoreboard thanks to special teams.

Pearland junior wide receiver Patrick Bridges shook off a C.E. King defender on his way to a 52-yard punt return for a touchdown. The punt hit a C.E. King player in the helmet and was deflected toward the sideline where Bridges was able to scoop it up and run for the score. The play was a bright spot in a mostly dismal game for the Oilers as they fell 45-7.

"It will be important for us to continue to work hard during the open week so we can be at our best next week in our first district game," Gotte said. "We will be playing a very talented and well coached Shadow Creek team, so it will be important for us to continue to improve in all phases of the game."

Pearland is open this week and will host the Shadow Creek Sharks on Friday, Sept. 23 at The Rig at 7:00 p.m.
