# City could call bond election

city voters on May 6.

Pearland city officials are expected to choose this Monday whether to put millions of dollars of needed drainage, parks and other capital improvement projects into the hands of

City Council holds its regular meeting at 6:30 p.m. Monday, Feb. 13, at City Hall, 3519 Liberty Drive. Meetings are open to the public and a period for public comment is provided. Those wishing to make a comment should sign up at least 15 minutes before the beginning of the meeting.

City Council is considering putting four

separate bond packages on the May ballot, with voters able to choose all, several, one or none of the items. The four propositions discussed are \$105.5 million in drainage projects, \$10 million in roads, just over \$33 million for parks and just under \$16 million for public safety. If approved, a \$181.3 million package

would have an annual tax impact of about \$24 on a home valued at \$250,000, according to Once completed, however, the new projects

would also add more operations and maintenance costs to the city's general fund. Monday's decision comes as the city con-

tinues to deal with a miscalculation that left the city approximately \$10 million overbudget for the current fiscal year. To shore up the budget, city leaders thus far have approved using savings, reallocating federal grant dollars and reducing transfers into ongoing savings funds created to finance vehicles and facilities.

The council is expected to hear a first quarter review of its financial position this Monday, and a capital improvement workshop is set for March 20.

### Spring to bring warmer temps, events

A cold and rainy February will eventually give way to a warmer-than-average spring, forecasters say, just in time for a slate of local events beginning in March.

In a just released 2023 Spring Forecast, commercial forecast service Accuweather predicts most of Texas will see temperatures two degrees higher than average, with even warmer previews of summer by mid- to late April. Meteorological spring begins March 1 and runs through the end of May.

### **Biotech company** eyeing Pearland for headquarters

A Houston-based biotech manufacturer could be setting up its headquarters in

The Pearland Planning and Zoning Commission on Monday voted 5-0 to recommend a zone change that would allow just over 6 acres at Pearland's northern city limit to be added to the adjacent LNR Clear Creek Planned Development. The undeveloped parcel lies on the southwest corner of Sam Houston Parkway West and Hooper Road

"The future occupant of this site would be Healgen Scientific LLC," Senior Planner Mohamed Bireima told members of the commission. "And their plan to develop a fourstory building which will be their U.S. headquarters."

City Council is expected to consider the request at its Feb. 20 meeting. If approved, the firm's plans for the site office and training space and research development.

"It is a predominantly undeveloped area," Bireima told the commission. "This would be the fourth incorporation into that same (planned development."

City staff has recommended the zone change be granted. The proposed building does deviate architecturally from those allowed in the planned development. But P&Z commissioners agreed renderings depict a quality product.

"This type of development is what we are seeking to inspire within the Lower Kirby District," commented Martin Griggs, assistant director of Community Development.

### Wireless tower recommended

Also on Monday, P&Z discussed and then opted to recommend a conditional use permit that would allow a 104-foot wireless communications tower at 1013 Main St.

While buffering is helpful, commissioners agreed complete screening of towers is difficult since they are taller than surrounding trees typically grow.

"It's the age that we live in — we want these phones and the coverage," P&Z Commissioner Derrell Isenberg said. "We've got to deal with what that comes with."

The site was selected to help fill a "coverage gap" causing lost signals and dropped calls, according to Richard Markus, representing Columns Inc.

Annexed in the 1960s, the nine-acre site has been used as warehouse space and as a furni-



#### ALPR public safety grant program

Grant funding is still available for neighborhoods to implement license plate reading technology designed to prevent and investigate crimes.

Automated license plate readers, or ALPRs, are computercontrolled camera systems often affixed to street poles, streetlights and highway overpasses that capture license plate numbers that come into view along with the location, date and time.

The program allows individual neighborhoods to install automatic license plate readers, which scan plates 24 hours a day, every day, storing data that can be shared with police departments to help in crime investigations.

Pearland Police one year began implementing the programs. Neighborhoods that have the readers installed them as a deterrent and typically place them at entrances and exits to communities and provide police with investigative leads for property crimes. Police are notified when a vehicle on a "hot list" passes a reader. Hot lists are vehicles that have been reported stolen or are associated with active warrants. For more information on the program,

### In The Garden by Karolyn Gephart









Rudbeckia (Black eyed Susan) February Is A Great Month For Gardening

Gardening in February is one where the weather dictates if you will go outside in short sleeves or bundled up with sweaters and warm attire. Yet, it is a month that has some

activities that must be done at this time. One such activity concerns roses. Around Valentine's Day (or by the end of the month), it is time to prune established roses (hybrid tea, floribunda and grandiflora varieties). Do not prune one time spring bloomers, climbing roses or antique roses until after the bloom cycle is finished.

Also with roses, do not fertilize newly planted rose bushes until after their first blooming cycle is completed.

If this is the year you want to create a pollinator garden, there are some plants that will work well and can be planted now. This is the month to plant the following plants to attract butterflies: ageratum (floss flower), phlox, buddleia, salvia, rudbeckia (brown eyed and black eyed Susans are pollinator favorites), bee balm (monarda) and lantana.

In Zone 9 (9a Friendswood to middle of Dickinson and 9b Dickinson to Galveston), when the soil temperature warms to 70 degrees (by the end of the month in years past) you can plan zinnias. Seeds for nasturtium, ageratum, portulaca, sunflower and torenia (Wishbone plant) can be

Start setting out gladiolus bulbs at two-week intervals now through early May to have an extended period of blooming to enjoy.

Plant bare-root roses, fruit and shade trees, pecan trees and dormant shrubs now. Established shrubs that are dormant can be successfully transplanted now.

Many of us have a March date that we bring our plumeria out of the garage or greenhouse but if evening temperatures remain at 50 degrees and above, you can pot plumerias and move them outside. (but always be ready to move

them back in to sheltered areas if there is a sudden late

For vegetable gardeners, plant onion sets and transplants throughout this month. Mid-February is the last chance you will have to plant

Irish potatoes for best yields. Plant beets, chard, collards, kale, lettuce, spinach, radish-

es and English peas now. Transplants of broccoli and cabbage should be set out before Feb. 15 and sweet corn should be planted after Feb. 15. Herb gardens can be started with rosemary, parsley, mint

and dill. Just a reminder about mint: it is invasive and can take over a garden bed so best bet for having mint is putting it in a pot or container so the gardener can keep control

St. Augustine lawns should not be fertilized at this time of the year until after the grass starts to actively grow.

Happy Gardening! Remember to wear gloves when working in soil and with plants and know that Spring is on the way!

### **Coward Creek or Cowart Creek?**

There is a minor mystery in Friendswood! Running through the middle of town is a creek that has always been called Coward Creek by residents. However, state maps, refer to it as Cowart Creek. Recently, TXDOT posted a new "Cowart Creek" sign by the bridge on FM518 going over the creek. They are wrong! At the urging of the Friendswood Historical Society, the city replaced it with a proper sign. So, what is that creek's true name?

Joycina Baker, who was Friendswood's official historian and a resident since 1948, used to get annoyed when she saw the creek referred to as Cowart Creek. In her

book, Friendswood A Settlement of Friendly Folk she says; "The spelling of Coward with a "t" (Cowart) is a corruption of the name that started appearing in local real estate maps in the 1960's." Seeing it called Cowart Creek was one of the few things that would really anger her. Once, when asked, she said at the time Friendswood was becoming more residential due to NASA Mission Control and real estate agents, didn't think newcomers would want to live along something named "coward."

When the Quaker settlers arrived in 1895, they simply adopted the names

Cowart

for creeks from what the locals called them, and they used the name Coward Creek without hesitation. The oldest map of the area is the original 1910 Platt map for Friendswood and is in the Galveston County land records. It is clearly demarked as "Cowards Creek" in this map.

The 1860 Census records show Allen Coward (clearly spelled "Coward"), along with his brothers Needham and Richard, living in Galveston County in an area called "Clear Creek." Galveston County Land Records have multiple listings in the 1850 to 1870 era for Allen Coward, including buying and later selling 1000 acres that clearly straddled the creek in question. The records spell his last name as "Coward" and are notarized. When the Quakers arrived, evidence of Coward's cotton plantation surrounding the creek was still evident.

Just south of present-day Friends-wood is a cemetery that has some early settlers to the area. This is Magnolia Creek Cemetery in League City. There are three "Cowards" buried there including Richard Coward and Needham Coward (Allen Coward's brothers.) Per their headstones, they

spelled their last name "Coward", and it is very unlikely that anyone would get this wrong on two headstones!

So clearly the state of Texas has miss-labeled the creek!

Cowards lived in the area preFriendswood and owned land surrounding the creek and land records

Family members are buried in a local cemetery and their headstones all read Coward.

spell their name as "Coward."



The earliest known map (1910) of the area shows it as Coward Creek.

Esteemed local historian Joycina Baker, published that the corrupted name of "Cowart" didn't show up until the 1960's and this was only in real estate maps that developers put out.

There is absolutely zero evidence of anyone named "Cowart" living in the area to give the creek its name.

So, the evidence is clear.....the name of the creek is Coward Creek and that is undisputed and don't let anyone tell you otherwise! It was correct for the City to fix the sign and Joycina Baker may rest in peace.



There are those special "moments" that we older folks need to capture in our mind and heart and never let them go. And if possible — to allow those "If only" moments to bless others.







### Pathways to STEM Careers, Strategic Partnerships help student land Boeing internship

Eric Washington said that if he could go back and tell his high school self what he's doing now, he'd never have believed it. "Before coming to University of Houston-Clear Lake, I had no idea I could ever work at NASA with astronauts. I would never have imagined I'd be doing this," he said.

Washington, who is pursuing his Bachelor of Science in Computer Science at UH-Clear Lake, reflected on his journey to landing an internship with Boeing, secured through an agreement signed in September 2022 enabling Boeing to offer engineering students entry-level engineering internships that support multiple projects.

After beginning his academic career at University of Texas at San Antonio, Washington quickly realized it wasn't a good fit for him.

"I came to UHCL after one semester at UTSA because I thought the degree program was better and much more affordable at UHCL," he said. "One of the most important things that happened to me when I came to UHCL is getting involved with Pathways to STEM Careers. They really supported me as a first-generation student. I came with the goal of getting involved in everything I could and just getting an internship—I didn't care where."

He said (Program Director for Pathways to STEM Careers) Andrea Alvarado had consistently kept him informed about opportunities like research assistantships.

"People should know the importance of getting involved with Pathways," he said. "They are out there to help propel students upward. If you're a minority or receiving a Pell grant, Pathways is an organization that will open doors for you, but they have high standards for staying in. You have to maintain a GPA of 3.0, but that just reinforces that if you keep studying, you'll have a job and go to school—you can't lapse; you have to put in the effort."

Through Pathways, Washington received a technical assistantship, and from there, he received a research assistantship with (Associate Professor of Software Engineering) Soma Datta.

"I took a project management lead role in helping her create a virtual biology lab," he said. "From Dr. Datta, I learned to program using a game engine called Unity. I learned about game design and acquired project management skills. I had a great experience and really enjoyed it."

But although he was applying for other internships, specifically at NASA, he was rejected from all of them.

"When I joined the National Society of Black Engineers, I met two students who were NASA interns and they told me to apply again," he said. "I finally got a NASA internship with the University Space Research Association and did flight software development, edited code and created an interface for the workout machine on the Artemis capsule. I had a great experience and met a lot of people. I learned what it was to be a software engineer."

He learned some programming languages along the way, as well as virtual reality development while at NASA.

"That brings me to this Boeing internship," he said. "I did not actually apply for it. I left my resume with (Strategic Partnerships Internships Coordinator) Bernadina Streeter. She is the one who called me and said my experience with VR development, game engines, and Unity was appealing to Boeing. They called me."

After practicing his skills with Streeter, Washington interviewed with Boeing and landed the internship.

"At Boeing, I'm creating a VR tool that allows engineers to demonstrate usage of the Pistol Grip Tool, which drives bolts on the International Space Station," he said. "We are creating a VR mockup to help us see if a tool fits in certain areas. We're using VR to find out if astronauts can manipulate the tool to bolt things down. If we can go in VR and do it, then we don't have to use more expensive resources."

He said he remembers his thoughts about what his career path might be back in his high school days.

"I thought I'd get a job in some software company and work at a desk," he said. "But after listening to the speakers I have heard while at UHCL, and getting the first NASA internship, I knew I would like to stay in aerospace. Now that I'm at Boeing, I get to go to work and say the software I'm working on is cutting edge. I'd like to retire someday from a career related to space."

Washington advises others in his position not to worry about making mistakes.

"That's what makes you human," he said. "But learning from them is what propels you to better positions. Never think there is just one way to do things. Don't limit yourself to a box. Remove the box! You can do anything you set out to do, it just takes time."

He said his internship at Boeing reaffirmed his desire to stay on this path.

"I go to work and I'm really happy with what I'm doing," he said. "This internship will make my ultimate career goal happen for me; UHCL is right across the street from NASA. This university has given me so many opportunities, and that's why I'm trying to do a good job for UHCL and Boeing."

City of Friendswood Early Notice and Public Review of a Proposed

Activity in a 100-Year Floodplain To: All interested Agencies: United States Department of Housing and Urban Development (HUD), Texas General Land Office (GLO), City of Friendswood,

This is to give notice that the City of Friendswood under Part 58 has determined that the following proposed action under the Community Development Block Grant - Disaster Recovery, CDBG-DR and contract number 20-066-045-C444 is located in the 100-year floodplain and the City of Friendswood will be identifying and evaluating practicable alternatives to locating the action in the 100-year floodplain and the potential impacts on the 100-year floodplain from the proposed action, as required by Executive Order 11988 and 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Protection of Wetlands. The project will include acquisition and demolition of repetitive loss structures in the floodplain. The floodplain area totals approximately five acres with twelve single family residential structures. The structures are adjacent to Clear Creek and sit within the 100-year floodplain. This project will benefit the natural function of the area by restoring the property to the floodplain, restoring habitat for wildlife and vegetation, and prevent future property loss and damages. The space will be utilized as greenspace. There are no adverse impacts to the floodplain or Clear Creek anticipated because of this project. The project will restore approximately five acres of floodplain to the area and will benefit the Community Rating System score. The proposed project is located, and impacts structures, on Deepwood and Woodvine in Friendswood, Texas, Galveston County.

There are three primary purposes for this notice. First, people who may be affected by activities in the 100-year floodplain on Clear Creek and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Comments are encouraged to offer alternative sites outside of the 100year floodplain, or Clear Creek, alternative methods to serve the same project purpose, and methods to minimize and mitigate impacts. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about the 100year floodplain, or Clear Creek, can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in 100-year floodplain, it must inform those who may be put at greater or continued risk.

Written comments must be received by the City of Friendswood on or before February 23, 2023. All written communication should note the following: Attention: Deepwood EA Review. #### Request for Qualifications and Scope of Work

The City of Pearland is requesting Statements of Qualifications (SOQ) from firms that can adequately demonstrate they have the resources, experience, and qualifications to fulfill the role of Engineering Design Consultant for the Melvin Knapp Activity Center (KAC) Outdoor Expansion project. The facility is located at 2424 Park Avenue, Pearland TX 77581. The respondent should select a team of professionals capable of providing the required services in an efficient manner in the best interest of the City of Pearland and that will provide successful, on-time, and on-budget project delivery. Information on all proposed sub-consultants should be included in the response.

The city is seeking a firm that meets the requirements of the RFQ. The firm is to provide architectural design and any applicable surveying and/or engineering professional services necessary for the enclosure of the current 1,500 -2,000 square foot open-air patio area, located in the west-southwest portion of the existing facility. The intent of the expansion is to extend the available program space at the Center, allowing additional square footage for exercise and fitness activities, dancing, holiday gatherings, and other structured enjoyment and entertainment activities. The successful Offeror will present the necessary qualifications, experience, capacity, and expertise for providing the architectural design elements to be used in the construction of the patio enclosure.

### The Intent of this Request for Qualifications

From this RFQ, the city will select a Primary Design Firm for the project. The project is envisioned to have a Primary Design Firm under the direction and management of the City's Engineering and Public Works Department - Capital Projects Division. The Primary Design Firm will be responsible for the successful management, design, and construction administration of the overall project. In addition, the successful Offeror will be responsible for managing, directing, and coordinating any and all teams of engineering firms and/or other sub-consultants it assembles to complete the required work.

### **Federal Funding**

The City of Pearland was awarded federal Community Development Block Grant (CDBG) funds from the U.S. Department of Housing & Urban Development (HUD) in 2020 (B-20-MC-48-0400), a portion of which has been allocated for facility improvements at the KAC. Some of the allocation will be used for the non-construction related costs of the project, which is comprised of the architectural design of the improvements described herein.

Both non-construction and construction costs of this project are funded by HUD, and applicable regulations may include certain federal Uniform Administrative Requirements (2 CFR 200), including but not limited to: Title VI of the Civil Rights Act of 1964 (Non-discrimination) and Section 3 of the HUD Act (24 CFR Part 135). Davis-Bacon Act labor provisions are NOT applicable to this phase of the project, as no construction activities are being solicited at this time.
