# 'irm gives report on budget error

An outside audit contracted after a valuation error led to a \$10 million budget shortfall in the City of Pearland found there was no "intentional deception" in the process.

"It was more of a communication breakdown," consultant Rodney Rhoades told council members during a report May 22. City Council in February hired the firm

Strategic Government Resources to examine

the city's overall tax calculation process and make recommendations. The valuation error occurred in August with Harris County properties that are within the city. After being built into the city's budget,

the error and resulting \$10 million shortfall

The error was attributed to incorrect tax calculations included in a Harris County Appraisal District worksheet that was ultimately used to create the city's budget and tax

was uncovered in November.

The assessment did not find any wrongdoing on the part of Pearland's city staff.

"I would stay your staff did a very nice job of reaching out and getting clarification," Rhoades said. "Some of the best practices recommendations address how in the future staff can be better prepared for that, but in general staff did a great job of asking questions to the best of their ability, and the answers they received from the tax assessor's office was that they had looked at the numbers and double-checked the numbers and everything looked appropriate."

Councilman Alex Kamkar said he had read the email correspondence and offered a different view.

"Those inquiries were one sentence inquiries. I wouldn't characterize that as thorough," he said.

According to the Brazoria County Tax Assessor, no comparison was made between certified estimates from July 2022 and the certified tax roll uploaded Aug. 31, 2022.

"Further, during this audit, the Brazoria Tax Assessor stated it was not their responsibility to compared certified estimates to final certified rolls," SGR states in its presentation to

"It's drastically different, and that should

have spurred some questions," Rhoades said. "The City of Pearland had relied on the Brazoria County Tax Assessor for 22 years. The reliance on their communication is really where the communication breakdown occurred between the tax assessor's office and city staff."

Recommendations included staff training on tax rate calculations, monthly communications and monitoring of communication with all three county appraisal districts involved and contracting with a company to do calculations to help ensure accuracy of numbers.

# Home repairs, nonprofits among grant options

Pearland will soon enter a public feedback period on how to best use \$466,000 in funding from the annual Community Development Block Grant Program.

The program funnels federal dollars to states, counties and cities to expand housing for low-income residents.

The funds are restricted to housing, social services or redevelopment activities. A 30-day comment period regarding how the funds are used will open June 26 with a public hearing. City leaders in August will develop a fiscal year 2024 action plan to be submitted to HUD for final approval.

Current projects under way using CDBG funds include a \$404,000 expansion at the Melvin Knapp Center that

entails enclosing the center's patio area. "As we get through the design phase and a clearer picture of what construction

costs look like, we may need to add more

funds to that project," special projects administrator Joel Hardy said.

In addition, a repair program will help owners of single-family homes with up to \$15,000 in repairs and code compliance.

"We've got about five or six homes that have been completed this year and another five on the horizon," Hardy said, "so we're getting back to 10 homes per year we want to make sure we touch on.'

Income limits for this program change every year, adjusted for wages and inflation.

"The median family income level of Pearland is \$111,400, and 80 percent of that is where we are capped as far as our ability to assist specific households," Hardy said.

Local organizations eligible to receive CDBG funding include the Pearland Neighborhood Center,

Counseling Connections for Change Inc., Gathering Outreach Community Services and SEVA Clinic.

# **Health council meetings** move to in person

A proposal to exempt Pearland ISD's health advisory council from audio and video recordings didn't quite fly with the school board.

Exempting meetings of the School Health Advisory Council from a recording requirement was among several recommended changes to PISD's District of Innovation Status brought to trustees May 16.

A District of Innovation designation gives Pearland ISD and other public-school districts that attain it more flexibility on things like school start dates and hiring procedures. The Pearland school board on May 16 OKed several changes to its current status but left off one regarding recording the health advisory council

"It's an impactful committee that I would have for the public not to have exposure to in a meaningful way," Trustee Crystal Carbone said.

The advisory committee review topics such as guidance services, mental health, vaping, district food services and other topics that often concern parents. Since 40 or more people typically participate, the meetings were moved to a Zoom format to meet the recording requirement, said Dr. Lisa Nixon, assistant Superintendent of Special Programs.

"It just doesn't have the same level of discussion in our meetings," she told the board. "There are things our group is missing out on, and there's not any place for us to meet and effectively capture that if we meet in

The meetings are all posted and open to the public,

"The difficulty is the quality of recording with that many people," Superintendent Larry Berger said.

Trustee Kris Schoeffler moved to strike the recording exemption from a list of District of Innovation

"(Zoom) stifles conversation, and you step over people and have technology problems," Trustee Kris Schoeffler said. "At the same time, if it has that much influence and information, I want to make it as accessible as possible and transparent as possible. I would rather see us invest in some technology and find a way to capture all the audio in person."

Rather than ending the recording requirement, trustees and staff opted to bring the meetings face-toface and try to record them. "Technology is everywhere and it's part of life now,"

Schoeffler said. "I know a solution exists."

Among changes that were approved by the board was exempting the district from a one-year commitment when accepting out-of-district transfers. This allows PISD to rescind a transfer any time during the school year for issues such as discipline and atten-

"If you're allowed the privilege of transferring into our district and you misbehavior or don't follow guidelines, we should have the ability to rescind your transfer here," board President Sean Murphy said.



## Sales tax up for May

Sales taxes returned to the City of Pearland this month were up 7.27 percent over the prior year, according to the Texas Comptroller's office.

Texas cities, counties, transit systems and special purpose districts are seeing approximately \$1.2 billion in local sales tax allocations for May, which is 4.3 percent more than the prior year, Texas Comptroller Glenn Hegar announced.

The allocations are based on sales made in March by businesses that report tax monthly, and on sales made in January, February and March for those that file quarterly.

# Boaters urged to clean, drain, dry

Texas Parks and Wildlife this summer is again reminding boaters to clean, drain and dry all watercraft to prevent the spread of invasive species.

Giant salvinia and zebra mussels continue to spread to new areas in Texas and remain some of the biggest threats to Texas lakes.

A free-floating fern that can double its coverage area in a week, giant salvinia produces thick surface mats that make fishing, boating or swimming nearly impossible. It is currently present in 27 Texas lakes and numerous rivers, creeks and marshes between Houston and Beaumont.

Now in 36 Texas lakes, Zebra mussels damage boats, alter lake ecosystems and harm native species. Once they become established, nothing can be done to control or eradicate them.

Boaters are urged to clean and drain boats and gear before moving from lake to lake and allow them to dry for a week, if possible. Anyone who spots invasive species on boats, trailers or equipment that is being moved may report it to TPWD at 512-389-4848. Anyone who finds invasive species such as zebra mussels in lakes where they haven't been found before can help identify new introductions by emailing photos and location information to aquaticinvasives@tpwd.texas.gov.

I have only a few memories of being around my greatgrandfather. He was my dad's mom's dad. His given name was Henry but in the family he was known at 'Grandpa Hank'' ... a tall slender man who some might describe as a 'hopeless romantic' caught writing poetry on the job more than once or twice and even found time to copyright some music he penned. I have two original songs of his and a folder of poems in his own handwriting in both pen and pencil I am transposing to chronicle his thoughts and prose. ## SCHS student receives Presidential Environmental Youth Award

In April, the U.S. Environmental Protection Agency (EPA), in partnership with the White House Council on Environmental Quality (CEQ), announced the 2023 recipients of the Presidential Innovation Award for Environmental Educators (PIAEE) and the President's Environmental Youth Award (PEYA).

Rahul Vijayan, Shadow Creek HS junior, was one of only 34 students in the nation who received this prestigious award.

His nonprofit, Farm-to-Tray (FTT) Hydroponics Farming in Schools, began in January 2022 when Earth Force granted him enough funds to purchase a hydroponic gardening system. In August 2022, after securing sup-

port from the Alvin ISD school board and Shadow Creek HS principal, Craig Rhodes, Vijayan successfully launched the system, which has since been a research tool for the school's AP Environmental Science curriculum and yielded five food harvests for 2,600 people.

Not only has Rahul brought this technology to his community, but he also encourages his community to further expand upon this work. He currently collaborates with the City of Pearland, Kroger's grocery stores, and even the National Aeronautics and Space Administration (NASA) to bring the benefits of his project to a wider audience. Additionally, he intends to bring new gardens to other

schools. His garden, and his teachings, will inspire others to add fresh, organic produce to the school lunch menu while ingraining the concept of sustainable agriculture into the student core curriculum.

Vijayan recently presented his vision for Farm-to-Tray to the Alvin ISD school board during the May meeting. He

also received a commendation from the Board for receiving the President's Environmental Youth Award.

The President's Environmental Youth Award was established by the Environmental Education Act of 1970 and recognizes outstanding community-level environmental projects by K-12 youth

that promote awareness of natural resources and encourages positive community involvement. Each year, PEYA honors a variety of local projects developed by students, school classes, summer camp attendees and youth organizations to promote engagement in environmental stewardship and protection.

"I would like to thank Alvin ISD, Ms. Shannon Oliver, and Principal Rhodes for their support and guidance in making my Farm-to-tray mission a success," shared Vijayan, "I could not have done any of this without each of you. I hope the future brings more success to our Hydroponic mission."

Pearland answered with a run in their half of the third when Raenna Liscano ripped a two-out double to left-center field to score Kennedy Drafton and make it 3-2.



APPLICATION AND PRELIMINARY DECISION. City of Friendswood, 910 South Friendswood Drive, Friendswood, Texas 77546, has applied to the Texas Commission on Environmental Quality (TCEQ) under Texas Pollutant Discharge Elimination System (TPDES) Small MS4 General Permit No. TXR040000 for a renewal of authorization number TXR040233 to discharge stormwater to surface water in the state from the City of Friendswood MS4. The notice of intent (NOI) and stormwater management program (SWMP) were received by the TCEQ on July 18, 2019.

The MS4 is located area within the City of Friendswood limits that is located within the Houston Urbanized Area in Galveston County, Texas. The discharge from the MS4 will eventually reach Clear Creek Above Tidal, Dickinson Bayou Tidal, and Dickinson Bayou Above Tidal in Segment No. 1102, 1103 and 1104, respectively, of the San Jacinto-Brazos Coastal Basin.

A copy of the NOI, stormwater management program (SWMP), general permit, and general permit fact sheet are available for viewing and copying at City of Friendswood Library, 416 South Friendswood Drive, Galveston, Texas 77546. The SWMP can also be viewed online at the City of Friendswood's website at https://www.ci.friendswood.tx.us/DocumentCenter/View/391/Storm-Water-Management-Plan-PDF. Substantial changes to the MS4's SWMP during the permit term will be posted on the same website.

The TCEQ Executive Director has completed the technical review of the application and SWMP. The SWMP, if approved, would establish additional terms and conditions, not included in the general permit, under which the MS4 must operate. The Executive Director has made the preliminary decision that the SWMP meets all statutory and regulatory requirements and made a preliminary decision to approve the small MS4's authorization under the TPDES Small (Phase II) MS4 General Permit No. TXR040000.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comments or to ask questions about the application. The TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing. If significant interest exists, the Executive Director will direct the applicant to publish a notice of the public meeting and hold the public meeting. The applicant must publish notice of a public meeting at least 30 days prior to the meeting in a newspaper of general circulation in the county where the MS4 is located. If the MS4 is located in more than one county, the applicant must publish notice in a newspaper of general circulation in the county containing the largest residential population.

To: All interested Agencies, Groups, and Individuals

This is to give notice that the Responsible Entity (City of Friendswood) under Part 58 has conducted an evaluation as required by Executive Order 11988. in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management and Wetlands Protection. The activity is funded under the CDBG-DR program under Grant No. 20-065-134-C451. The Proposed Action (project) will include the removal of an existing aerial utility crossing over Clear Creek and the installation of an 8-inch diameter water line and a 24-inch diameter force main beneath Clear Creek utilizing boring techniques. The project is located on the western side of Bay Area Boulevard, southwest of the Blackhawk Regional Wastewater Treatment Plant and east of the Polly Ranch Airport, in the City of Friendswood, in Galveston and Harris Counties, Texas. Outside of Clear Creek, the pipelines will be installed through open cut. The new water line and force main will connect to existing utilities on each side of Clear Creek. The project is located on approximately 2.5 acres of land. The Proposed Action area includes approximately 2.41 acres of 100-year floodplains, including 1.05 acres of floodway.

The City of Friendswood has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values. The Proposed Action must take place in a floodplain because the existing infrastructure to be removed/replaced is already located in a floodplain. Further, it will still connect existing essential infrastructure on both sides of Clear Creek; it will not cause current residents to become displaced; it will be located on uninhabited property where the City of Friendswood either owns or has an easement to avoid costly land acquisition; it will be located within the Friendswood City limits in order for City funding contribution to be available; it will remove the existing utility bridge that poses safety risks for area residents that frequently climb and jump off of the utility bridge; and it will protect essential utility infrastructure by placing under-

Two alternatives for utility relocation were considered, including a No Action Alternative. Alternative A would involve relocating the utilities within other areas that would be located outside of the 100-year floodplain. The portion to be relocated must still connect to existing infrastructure on either side of Clear Creek that is still located within the 100-year floodplain, so there are no other areas in this portion of Friendswood that avoid the 100-year floodplain and still allows connections to existing infrastructure on either side of Clear Creek. Rerouting in a different location would require increased construction costs and costly land acquisition outside of areas already being used for these utilities by the City of Friendswood. Alternative A is not practicable. Under the No Action Alternative, the utilities would not be relocated, 100-year floodplains would not be impacted, safety risks would still be present for area residents that climb and jump off of the utility bridge, and essential utility infrastructure will not be protected. The No Action Alternative would not contribute to a reduction in loss of life and property from flooding. The No Action Alternative would not meet the need and purpose of the project.

Given that the Proposed Action would not result in significant adverse impacts, mitigation measures are not proposed. Additionally, the Proposed Action would involve removing above-ground infrastructure which will allow for positive drainage improvements.

The Proposed Action would be in compliance with state and local floodplain protection procedures.

The City of Friendswood has reevaluated the alternatives to construction activities in the floodplain and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of Executive Order 11988 are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information and request for public comment about floodplains can facilitate and enhance Federal efforts to reduce the risks and impacts associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at greater or continued risk.
