A once delayed age-in-place community known as the French Quarter is in the works again after a second reading passed Pearland City Council Oct. 25.

Approved during the council's consent agenda was the final reading to reinstate the expired planned development for the French Quarter, a 62-acre tract in the 3900 block of Pearland Parkway.

The planned development zoning was originally approved in 2020 but expired after the developer took on additional design work to address drainage con-

A project of R. West Development, the French Quarter is designed as a mix of single-family homes for active adults, independent living apartments, assisted living and memory care.

Also passing final readings in the consent agenda Oct. 25 were a zone change for newly annexed 15 acres at 3525 Charles Avenue to suburban residential, another zone change to suburban residential for a recently annexed 7.7-acre tract at 5806 Bailey Road and a planned development zone for nearly 80 acres that will become part of the Massey Ranch com-

Despite rain, county under burn ban

Despite recent rainfall with more predicted, Brazoria County enacted an outdoor burn ban Oct. 26.

"It's drier now than it was as far as fire danger," the county's Emergency Coordinator Steve Rosa told county commissioners when the ban was enacted. "After the last cool front we had, people wanted to get outside. They wanted to clean up and there were lots of fires started. Last weekend, we had two structure fires in the county caused by outdoor burning."

The ban prohibits outdoor burning in unincorporated areas with the exception of container barbecue grills; burning is not allowed inside Pearland city

Texas counties issue burn bans based on a number of factors, one of which is a drought scale maintained by the Texas A&M Forest Service. The Keetch-Byram Drought Index, as it is known, ranges from zero for completely saturated soil to 800, representing absolutely dry conditions with the highest risk of fire.

Brazoria County began the week with an average index of 541, with some areas as high as 633, according to the forest service. More rain is on the way. Scattered thunderstorms are forecast this

Saturday, with showers expected on Monday. The burn ban expires in 90 days but could be lifted sooner if the average KBDI index falls below 400 for five consecutive days.

This week 139 of Texas' 254 counties were under a burn ban, including neighboring Galveston, Harris and Matagorda.



Garden Tasks to do in November

November in our area can be mild with a few days of cool sprinkled here and there. Time will tell but there are several tasks for gardeners to do this month no matter what the temperature.

Plant English peas or snap beans, turnips, radish, spinach and mustard greens this month. Last call is being made to plant parsley, lettuce, and beets.

Set out pansy and viola transplants. Plant dianthus, stock, candytuft, calendula, and alyssum transplants now. These young plants are being offered now at various

nurseries and big box stores.

Plant the following bulbs outside: alliums, amaryllis, crocus, fodils, freesias, Leucojum, muscari, and rain lilies. Chill tulip bulbs for six to eight weeks. indoor enjoy-



ment, plant paper white narcissus, hya-cinths, and crocus bulbs in pebbles or water. Enjoy them for the holidays. Amaryllis bulbs can be easily forced to bloom for Thanksgiving and Christmas. Forcing new amaryllis bulbs in late December, they will bloom for Valentine's

As chrysanthemums and other perennials finish blooming, cut the flowering stalks to the ground to encourage all the strength to be used in root growth. Pinch off the tops of calendulas, delphiniums, snapdragons, and stock to promote bushy growth. Now is an excellent time to plant trees. Transplanting

during the winter months allows the root system of the plants to become established prior to spring growth and summer heat. Do not fertilize newly planted trees or shrubs. Fertilize instead next spring after the plants have put on new growth. Prune oaks and other shade trees now through Jan. 31.

Prior to bringing houseplants inside for the winter, check them for signs of scale, mealy bugs, and spider Trees are losing leaves around us and some even have

color changes but don't let them stay on your lawn. Keep leaves raked for a healthier lawn and to reduce fungal leaf spot problems of trees.

Enjoy the fall weather by participating in these gardeners tasks for this time of year.

Free legal clinic for Veterans set for Nov. 7

Metroplex Veterans Legal Services is conducting a virtual Veteran's Expunction and Orders of Non-Disclosure Legal Clinic on Monday, Nov. 7 at 2:00 pm. This clinic is a partnership with the law firm of Sidley Austin LLP, and American Airlines.

This clinic also focuses on assisting all of the Harris, Brazoria and Montgomery County Veterans Court program graduates with the expunctions or orders of non-disclosure from their criminal case. This free legal program offers services to the graduates of the Harris, Brazoria and Montgomery County Veterans Court without restrictions

on eligibility based on the Veterans current income. An Expunction removes all records of an arrest and/or subsequent court case from the public record and the individual may legally deny or fail to acknowledge ever having been arrested for or charged with any crime which has

been expunged. A record of an arrest without a conviction

is a barrier for employment. An order of nondisclosure is a legal remedy available to people who successfully complete deferred adjudication probation, in which a Texas court orders that your criminal history on a particular case be sealed from public view. A criminal history can be a barrier for housing.

Metroplex Veterans Legal Services offers single issue legal clinics to Veterans on a pro bono basis. Our legal clinics focus on removing the legal barriers to employment for Veterans, and assisting disabled Veterans to obtain military disability benefits.

Our legal clinics address three of these unmet legal needs, for child support modification, restoring driver's

licenses, and legal assistance for warrants and fines. The clinic will be held virtually on Nov. 7 at 2:00 pm.
