# Error leaves city with deficit

The City of Pearland is facing a \$10 million revenue shortfall due to an inaccuracy in tax calculations for Harris County properties, City Council members learned this week.

"We've had a calculation of our values change from when we did our budget several months ago, and it's a rather drastic change in our value," Mayor Kevin Cole said during a discussion Monday night. "This was found almost by happenstance as we were looking to create TIRZ No. 3 (and) calling for values again. Those values when they came back in from the county didn't match up with what we had before."

The miscalculations were uncovered only within the last two weeks.

"I've really got more questions than answers at this point," Councilman Tony Carbone said Monday night. "This is reminiscent of the whole water billing issue."

Councilmembers grappled both with how the mistakes happened, what to do about it going forward and how it will affect the city.

"The tax rate it set. That will not change," City Manager Clay Pearson said. "The city rate is lower than it would have been otherwise, but that's set now."

Water and sewer rates are also not impacted, he said.

What is changed, however, is the amount of revenue generated from property taxes in the city's general fund and tax-backed debt funds

— it is far less than budgeted.

In such a situation, city policy recommends deferral of capital equipment purchases, hiring freezes, using fund balance and fee increases, among other measures.

The council will consider ways to shore up the budget at its Dec. 5 meeting via budget amendments.

"That will allow us more time to talk to our financial advisor and develop solutions," Pearson said.

"Obviously this is something we will be talking about for a while and try to avoid this ever happening again," Councilman Adrian Hernandez said.

Pearland includes three counties: Harris, Brazoria and Fort Bend. Each county's appraisal district determines assessed values, which are collected and calculated by Brazoria County into a tax rate calculation worksheet provided to the City of Pearland.

"We need to have an independent third party come in and review the documentation, talk to all the parties and tell us where did we fail, where can we get better and what can we do in the interim," Councilman Alex Kamkar said. "The reality is we are one of 16 cities that have three counties. We are not the first city to have three county jurisdictions involved."

"We failed," Kamkar continued. "We now have \$10 million that we are going to have to go find and it's going to be uncomfortable."

All city meetings are livestreamed and posted on the city's website at pearlandtx.gov, and on the city's YouTube channel.

## Opposition thwarts Hatfield project

Pearland City Council on Monday rejected a zone change that would have allowed a subdivision to develop near West Orange and Hatfield.

Even though four of the three council members voted in favor, approximately 28 percent of adjacent landowners opposed the zone change. This triggered a city policy requiring a supermajority vote of council, or six out of seven votes, for it to pass.

The request was to rezone 12 acres south of West Orange and east of Hatfield from a single family residential zone known as R2 to a single family residential zone of R3. The R3 zoning permits higher density and smaller lot sizes than R2. In this case, the proposal called for homes priced from \$425,000 to \$475,000 on 7,000 square foot lots.

Councilman Adrian Hernandez was among those voting in favor of the change to R3.

Several neighboring property owners addressed the council on Monday.

"It's easy to say, 'It's just more homes' when you're not living next to it and you're going to have 10 or 11 houses alongside your home," said Laura Jiminez, who lives next to the site. "My concern is the noise. My concern is the traffic and the zoning of the schools."

Councilman Alex Kamkar voted against. "Progress happens, and I hate to say it, but these people were here first," Kamkar said, referring to neighbors who spoke in opposition.

The city's Planning and Zoning Commission voted 3-2 to recommend the zone change at its Oct. 17 meeting. The property is currently vacant and remains zoned as single family R2.

The first-ever Pearland Restaurant Weeks was developed through a collaboration among Harold Wong of Pearland's Boiling Dragon and Phaedra Cook of Houston Food Finder as well as the Pearland Convention and Visitors Bureau.

"This project team is very passionate about supporting both the restaurant industry and the wider community and we hope to see the event flourish into something that truly makes a difference," said Pearland Convention and Visitors Bureau Executive Director Tracy Rohrbacher. A portion of the proceeds of every Restaurant Weeks meal will be donated to the Pearland Neighborhood Center, which provides a variety of social services to Brazoria County residents, including a food pantry, rent and utility assistance, school supply vouchers, financial stability classes, health care and emergency assistance.

"There is so much more this organization does to help our community," said Wong. "We could not be happier to be partnered with them for this great cause."

## Pearland routs Hastings 59-7, playoffs next

It's not how you begin but how you finish, and the Pearlland Oilers finished the 2022 regular season with a 59-7 win over the Alief Hastings Bears for a 6-4 overall record. Now, the Oilers will ride into the Class 6A Region III Div I playoffs with a three-game winning streak and the post-season for the 23rd straight year.

Pearland will face the Dickinson Gators on Friday, Nov. 11 at 7:00 p.m. in the 6A Region III Div I playoffs at The Rig.

The Oilers closed out the regular season under new head coach B.J. Gotte with a positive statement while building momentum in the next step of the season.

"I was very pleased with how we wrapped up the regular season with our best all-around performance," Gotte said. "This season we have talked at length about controlling our ability to execute at a high level and play clean football in all three phases regardless of our opponent."

Pearland did just that against Hastings in the blowout victory. Hastings surprisingly scored with ease on the first possession of the game going 75-yards in seven-plays to score on an 8-yard run with 9:41 left in the first quarter for a 7-0 lead.

The Oilers would outscore the Bears 59-0 for the rest of the game.

It took Pearlland only three plays to tie up the game as senior running back Kennedy Lewis went 59-yards on a scoring pass from QB Jackson Hamilton to even up the score 7-7 with 8:33 left in the opening period.

With 1:44 remaining in the first quarter, Pearlland would score again as Lewis crossed the pay station on a 7-yard run to make the score 14-7.

At the beginning of the second quarter, Zander Winters would recover a Hastings fumble at the Bears 29 and the Oilers would score on a Hamilton 12-yard scoring pass to Evan Gracia with 8:19 left in the second quarter for a 21-0 advantage.

After the ensuing kickoff to the Bears, the Pearlland defense would be back in the end zone as Jaden Wincher intercepted a pass and returned it 26-yards for a score with 7:14 left in the second frame for a 28-7 lead.

The Oilers would add one more score before the end of the first half when sophomore running back LaDamion McDowell would score on a five-yard scamper for a 35-7 halftime lead.

"I felt that after the first drive of the game, we settled in and played up to our capabilities," Gotte said. "It was also a special night to get to see all of our seniors contribute on the field, because as a coach, you always love to see your players get excited for others on game night."

The Oilers would score 24 more points in the second half

in the 59-0 rout of the Bears.

Hamilton would throw two scoring passes to Patrick Bridges covering six-yards and then hit Christian Pitts on a 15-yard scoring toss to make the score 49-7 with 2:22 left in the third quarter.

Junior kicker Jackson Stagg, who hit 7-for-7 extra points for the game, booted a 34-yard field goal early in the fourth period to make the score 52-7.

The final Pearlland score came on a 19-yard scoring pass from junior QB Cole Morkovsky to senior wide receiver Bryson O'Neal to put the finishing touches on the 59-7 final score.

Hamilton was 9-of-14 passing for 149 yards and four touchdowns while Morkovsky was 4-for-4 passing for 51 yards and one TD.

McDowell had seven carries for 107 yards and one TD while Lewis had 49 yards on nine totes.

Pitts had three catches for 43 yards and one score while O'Neal had three grabs for 42 yards and a TD and Lewis had one reception for 59 yards and a score. Bridges added two catches for 22 yards and a TD.

"We now move on to the third and final phase of our season, with a home playoff game vs. Dickinson," Gotte said. "It is time for us to take the experiences and lessons learned throughout the season and use them to be at our best on Friday."

**GREAT EXPECTATIONS**

*"So now Israel, what do you think GOD expects from you? Just this: Live in his presence in holy reverence, follow the road he sets out for you, love him, serve GOD, your God, with everything you have in you, obey the commandments and regulations of GOD that I'm commanding you today—live a good life."* - Deuteronomy 10:12-13

Here's an old Hebrew story to make us think... There was a rabbi whose days were long with having not much life left in him. His name was Yeshua... the name we would say out loud as... 'Joshua!' A new and younger rabbi had now been chosen to walk with Yeshua in his final days to meet the people and to learn of the details of daily life in the synagogue. They talked of many things... the old and sacred things of God and the things of what was to come. 'Has this been a good life for you, rabbi?' asked the younger scholar. 'Yes, o yes!' Yeshua responded quickly and with a certain sense of satisfaction filled with a confident hope... 'that's good,' the young rabbi replied. 'Yes, it is...' torted back Yeshua... 'yet, I have just one worry.' The younger rabbi looked stunned but heard the concern in Yeshua's voice. 'What are you worried about? That when you die and stand before God you will be asked... why weren't you more like Abraham?' Yeshua glanced back then lowered his head... saying... 'no, not that.' 'Are you worried God will ask you why you weren't more like Moses or one of the prophets?' the young rabbi continued... 'No, I'm not worried about that, either?' said the dying old man... 'I'm worried that when I stand before God... I will be asked... why weren't you... Yeshua?'
