City looks at funding for parks

City leaders talked numbers Monday in a workshop focused on the amenities that play a lead role in Pearland's quality of life.

A five-year capital improvement spanning from 2023 to 2027 calls for more than \$33.1 million to be invested in the city's green-space, sports and recreation facilities. The city's fourth largest department, Parks and Recreation manages nearly 550 acres of parkland, 14 parks, four recreation centers, the city's natatorium and 27 sports fields.

"In the upcoming year, parks and recreation is planning an in-depth review of our service delivery as it relates to our cost recovery model," Parks and Recreation Director Carry Capers told city council during Monday's special meeting. "One area of focus is evaluating our current partnership

agreements to ensure they are in line with cost recovery policy and that there is an appropriate and equitable sharing of revenues between the city and the service providers."

The ultimate goal, she said, is a business model that makes the parks and recreation program economically sustainable in the future.

Over the past five years, the department's operations and maintenance budget has stayed relatively flat, she said, "while we've seen a significant increase in assets we maintain."

In 2019, voters approved \$2.9 million in bonds that have added lighting at Centennial and Independence Park, trails and playgrounds and irrigation at 14 parks.

"We just recently awarded that contract to start diving into repairs for irrigation," Capers said. "At 14 parks irrigation was not functioning properly or at all."

Upcoming contracts funded through 2019 bonds including replacing old shade structures and adding shade to playgrounds.

Also set to be funded are accessible sidewalk connections throughout parks.

The council on Monday discussed the designating funding to be used for parks upkeep vs. rolling it into bonds.

A list of priorities for a possible future bond program includes the next planned phases for Hickory Slough Sportsplex, Independence and Centennial parks, but the

majority are new segments of the Clear Creek Trail, the master plan for which was developed using community and stakeholder feedback.

The 21-mile trail system will ultimately connect FM 521 to Dixie Farm along Clear Creek.

"We've had eight miles already completed and others slated with our partnership with TxDOT," Director of Engineering Robert Upton said. "This is in planning and working with the flood control district to be able to put the trail in or have it set aside during their Clear Creek project."

The trail will provide a way for cyclists and pedestrians to get from one place to another without having to deal with auto traffic.

"It will realize a dream we had years ago," Mayor Kevin Cole said. "A city connected by trails and not just roadways, those things add to the quality of life."

PISD forums draw parent feedback

Parents of Pearland school students attending face-to-face forums expressed concerns on everything from bullying to restrooms to procedures regarding students charged with felonies.

"I can't solve problems if they are just posted on social media," Pearland ISD Superintendent Larry Berger said during the first District Talk session held Oct. 6. "I want to work with our community to solve problems. We are focused on the kids, figuring out what is best for each individual student, and sometimes compromise has to happen."

The series of discussions is being held at campuses all month, inviting parents to share and discuss concerns and ideas. Upcoming forums are 6:30 p.m. Oct. 20 at Pearland Junior High East; and 6:30 p.m. Oct. 27 at Pearland Junior High South.

One of the issues brought up by parents in the first session was a student charged with felonies who had returned to campus.

"We are controlled in discipline by the Texas education code," said Berger. "A student can commit a felony, be disciplined, be sent to an alternative education placement off

campus for 30 or 60 days. When they finish that discipline, they come back to the school."

Other parents were concerned about bullying, an area where Berger said campuses are always working to improve.

An anonymous bully reporting system is not currently functioning; Berger said the district's tech department is working to set up a replacement.

"Since COVID, we have seen the social behavior of our students deteriorate," Berger said. "We have seen more behavior issues, more acting out. We don't know why; we sit and talk about it and what we can do to prevent it."

Another topic discussed was campus safety. In addition to periodic exterior door audits, unannounced entry checks are done weekly by district staff at campuses. For safety reasons, much of the district's safety procedures are discussed by the school board in closed session.

"We have fortified our buildings. We have put security vestibules in. We've added cameras, we've added fencing," Berger said. "People have asked about metal detectors. That's not practical in a school."

In Pearland High, for example, there are 70

entrances and exits and 3,200 students.

"To force everyone to go through a metal detector process like TEA is not practical," he said. "We do have hand wands at the schools. We have to use them."

A recent "drill day" at Turner High School went well, he said, and the district is looking at replicating this at other campuses.

"It does take away from instructional days, but safety is our No. 1 priority," he said.

One parent asked about restroom policies. Pearland schools currently have single stall restrooms designated for use by transgender students.

"It is a touchy subject legally and socially, but we want to make sure in school that everybody is supported and feels comfortable," Berger said. "It is a very fluid situation right now legally."

Discussion has included the Pearland Homecoming Dance, which caused frustration after ticket sales were limited.

"I will admit fault on the district's side that when the tickets initially went on sale, we did not communicate it well that there was limited capacity," Berger said, "and if we would have done that in the beginning, then a lot of (frustration) could have been avoided."

Plan to target 'missing middle'

A proposed new section of Massey Oaks master planned community would target what developers described as the "missing middle," or housing types such as duplexes and courtyard homes.

Pearland City Council on Oct. 10 approved the first reading of a rezone that would incorporate just under 80 acres south of Old Massey Ranch Road into the master planned community. The tract is east of the future Harkey Road and west of McLean Road.

The plan calls for duplexes, single family residential and "four-pack" residences featuring shared driveways.

In real estate, the "missing middle" is described as residential units in clusters such as duplexes, fourplexes, cottages and courtyard buildings, usually in walkable neighborhoods.

"We're also proposing a trail system across Cowart's Creek diversion channel, which will allow this part of the community to connect to the remainder of the Massey Oaks development," said Andrew Lang, BGE, representing the property owner.

Chesmar Homes has five communities under way that include detached four-pack units. The average sales price for is around \$325,000, according to Jeff Johnson of Chesmar.

"It is more affordable, but these homes are not designed to look any less expensive," he said.

Also planned for the tract are attached, three-bedroom duplexes and traditional single family homes.

If you have been a victim of this type of event, please contact your local police agency and file a report.

CONTRACTOR SCAMS

Home improvement scammers will often ask for payment up front. Some simply disappear with your money. Others will do shoddy work or claim to have discovered some hidden problem in your house that needs immediate attention and significantly raises the cost. Crooked contractors look to prey on people they view as vulnerable. If your house has been damaged by a storm or natural disaster, for example, a scammer might show up and promise fast, cheap repairs, or try to persuade you to sign over a payment from your insurance company. How to protect yourself from this scam:

- Do insist on seeing references. The Federal Trade Commission (FTC) recommends asking past customers detailed questions, including whether the project was completed on time and if there were unexpected costs.
- Do require a bid in writing and compare bids from multiple contractors before agreeing to any work.
- Do check the Better Business Bureau (BBB) website to see contractors' ratings and whether any complaints have been filed against them.
- Do get a written contract before you pay any money and before the work starts.
- Do verify before making the final payment that the work has been done to your satisfaction, subcontractors or suppliers have been paid, and the job site has been cleaned up.

Rotary Regatta paddles through another year

The 5th Annual Rotary Regatta took place on Clear Creek on Sunday morning. The seven mile race began at 9am in 1776 Park and finished at Lynn Gripon Park in League City.

Roughly 40 boats with more than 50 intrepid paddlers participated in the event this year, some finishing in under an hour. Although most, including yours truly, took closer to two hours to complete the course.

The event has been an annual fundraiser for the Friendswood Rotary Club, championed by former club president and competitive canoe racer Luis Briones. Briones and

his teammate, Joel Truitt, finished in first place in the Men's Recreational Canoe category.

Pearland finally got on the scoreboard at the 8:06 mark of the second frame when sophomore QB Jackson Hamilton tossed a short pass to junior WR Patrick Bridges at the Dawson 46 and turned on the jets to weave his way to the goal line to complete the 51-yard throw and catch for the score to cut the lead to 14-7 which stood at intermission. Jackson Stagg booted the PAT.

The Oilers did cross the red zone late in the second quarter when they drove from their own 38 to the Dawson 14 only to lose a fumble which was recovered by Dawson junior Gabriel McFarland to close out the first half.

Dawson scored their only touchdown in the second half with 6:58 left in the third quarter when Burgess scored on a 6-yard run to make the score 21-7. The scoring drive covered 12-plays and 69-yards.

The Oilers could not get any consistent offense in the second half as a result of a strong defensive effort by the Eagles.

Pearland finally made a touchdown late in the fourth

"We have a great opportunity to work on securing a playoff spot this week, so we need to turn our attention to a very talented Alief Taylor team. It is important that we grow from last week's experience and continue to take steps in the right direction as a program."

Leading the Dawson offense was Johnson who was 15-for-22 passing for 201 yards.

Bryce Burgess had 26 carries for 108 yards and two touchdowns.

Jaeden McCleskey had three catches for 69 yards, Joseph Brown had seven grabs for 49 yards, and Josh Gillis-Harry had two catches for 48 yards.

Pearland was led by Hamilton who was 8-for-16 passing for 168 yards and two scores.

McDowell had 13 carries for 41 yards rushing while catching two passes for 61 yards and one score.

Bridges had five grabs for 102 yards and one TD.

Dawson will face Shadow Creek on Friday, Oct. 21 at 7:00 p.m. at Freedom Field. Both teams enter the game with 4-0 district records and this game will more than likely determine who wins the District 23-6A championship.

Pearland will host the Alief Taylor Lions in a critical district matchup as both are battling for a spot in the post-season. The game will be at Pearland ISD Stadium on Friday, Oct. 21 at 7:00 p.m.

Friendswood takes out Terry 30-6 on Homecoming night

In a must-win game, the Friendswood Mustangs beat the Rosenberg Terry Rangers 30-6 before a Homecoming crowd to keep their playoff hopes alive.

The Mustangs evened their season at 4-4 overall and 3-3 in district with two league games remaining to play in the regular season.

No. 6 area-ranked Angleton (5-2, 4-1) and No. 3 area-ranked Magnolia West (5-2, 3-2) are the final two teams on Friendswood's district schedule in their quest to extend their football season.

Faced with controlling their own destiny — the Mustangs next obstacle is the Angleton Wildcats on Friday, Oct. 21 at 7:00 p.m. at Wildcat Stadium in Angleton.

ON BOTHERING GOD

For a long time, Israel didn't have the real God, nor did they have the help of a priest or teacher or book. But when they were in trouble and got serious, and decided to seek God, the God of Israel, God let himself be found. At that time, it was a dog-eat-dog world; life was constantly up for grabs—no one, regardless of country, knew what the next day might bring. Nation battered nation, city pummeled city. God let loose every kind of trouble among them. "But it's different with you: Be strong. Take heart. Your reward is coming!"
~ 2 Chronicles 15:1-7

I'm a gregarious kind of guy. I like to be around people... and I pray that people like to be around me. At least most of the time. Afterall, we were created for 'community.' It was not good for the man to be alone is the reason the Bible includes that small and important detail why God created the woman also... and if you hone in on the big picture it's easy to see that when it comes to God and people... our life together is referred to in the plural... with phrases like ... 'people of God' ... or 'community of faith' ... or 'children of the heavenly Father' ... and 'body of Christ' with all the parts important... according to St. Paul.

Wow! Faith matters. Persistence counts. Determination rules the day!

Horace Mann once wrote... "Let us not be content to wait and see what will happen but give us the determination to make the right things happen..." for if a powerless widow can finally wear down the power of injustice... the just God in whom we trust won't mind our bothering him more than we have or haven't... so... bother away. God likes it!

Deadly crash under investigation

Police are still investigating a deadly rollover crash that killed five people and injured others on the Highway 288 frontage Saturday evening.

Names of accident victims are not released by investigating agencies until family members have been notified.

Reported at 7:38 p.m. Saturday night, the crash involved two vehicles, one traveling "at a high rate of speed," according to a release from the Pearland Police Department.

The accident occurred in the 14700 block of the 288 frontage road near the Cracker Barrel restaurant.

According to Pearland Police, one of the two vehicles in the wreck rolled over and ejected four of the five occupants: Three died at the scene and the other was transported but died at the hospital. The fifth occupant of the vehicle remained hospitalized this week. Initial reports did not indicate if seatbelts were worn.

The driver of the other vehicle was taken to the hospital and later died, but two juveniles in that vehicle were transported to local hospitals for treatment.
