Without rain, drought plan may move to Stage 2

If the ongoing drought continues into September, Pearland will likely go to Stage 2 of its drought plan, city officials say.

"People want to keep their yards alive and we understand that" City Manager Trent Epperson said during an Aug. 23 update. "That takes a lot of water."

Due to sparse rain and record heat, Pearland has been in Stage 1 of its drought plan for several weeks. This voluntary stage requests that residents limit watering to the days they receive garbage service and water only at night.

"As the drought went on, we started to see usage tick up and up and up to the point we enacted stage

1 of our drought contingency plan," he said. "We do see a littler moderation but as the drought continues to drag on, we continue to see usage move up."

Personnel in charge of water production are closely monitoring water supplies daily, Epperson said. A few areas received some rain during the past

week, but this "by no means" ends the drought, he said. "We did see a drop in usage just based on that short

bit of rain," he said, adding that this will likely keep the city from going to Stage 2 for a bit longer.

Stage 2 is similar to Stage 1, except the restrictions are mandatory vs. voluntary.

"If we do have repeat offenders we have enforcement mechanisms," he said.

Changes made to proposed apartments

A developer proposing urban apartments near Fite and Manvel roads has submitted a revised plan based on concerns from the community expressed back in May.

Pearland council and planning and zoning held a workshop Monday regarding the 9.6-acre tract north of Fite Road and East of Manvel Road. The workshops are meant to provide feedback for developers before further investments are made.

Council members and P&Z overall appeared receptive to the revised plans, so long as those with concerns had been contacted.

"You said you've reached out to West Oaks and the Dad's Club," Councilman Tony Carbone told the applicants. "The really expensive 'no' is when the Dad's Club fills up (council chambers) and it fails."

Changes to the original plans call for reducing the number of living units to 180 and taking the building from four stories to three.

Initial concerns included traffic congestion, particularly due to its proximity to the Pearland Area Dad's Club on Fite Road. In response, a planned coffee shop was removed from the plan and a roundabout was added, among other changes.

Karla Canada, representative of the applicant, said they contacted the Dad's Club and nearby HOA to set up meetings.

"We have reached out to the area to let them know what the proposal is," she said.

Plans call for 110 two-bedroom units and 70 one-bedroom units with amenities such as pool and playground.

Officers sought as district works to meet mandate

Pearland ISD this month will join countless Texas school districts asking for more time to fully implement a new -- and costly -state law that goes into effect this

Signed into law June 13, House Bill 3 mandates every public school in Texas provide at least one armed individual on campus.

"What did not come with that was funding that will cover it," Pearland ISD Superintendent Larry Berger told board members during an Aug. 21 discussion on how to meet the requirement. "Just like there's a shortage of qualified teachers, there's a shortage of police officers."

The mandate does state that districts may claim an exemption based on funding or staffing shortages, and the district currently has both, Berger said.

House Bill 3 was not completely unfunded: It increased the per "student safety allotment" by 28 cents per student and provides school districts with \$15,000 per campus to help implement the mandate. This extra funding adds up to \$558,000 per year -- hardly enough to cover what would cost Pearland ISD \$4.8 million.

The local school district does have safety programs that include security personnel on campuses.

"Currently, PISD has a partnership with the City of Pearland which we greatly value that allows us to have (security officers) at our high schools and our junior highs," Berger said during the Aug. 21 discussion. "We currently pay \$1.3 million for those officers."

To fully cover the district's middle and elementary schools would cost another \$3.5 million.

The board agreed Aug. 21 to request an exemption while developing a safety plan that hires more officers who will rotate among middle and elementary campuses.

The exemption is available "as long as we have a plan in place and there is a timeline when funds and personnel become available," he said.

Another option provided by the mandate is to arm teachers and staff through a guardian program.

"There are so many errors that can happen in the midst of that," Trustee Crystal Carbone said. "I would rather leave that to the professionals."

Pearland wins season opener 45-41 in a nail-biter

If you wanted a close game that would be decided at the very end, then you would not have been disappointed in the non-district season opener for the Pearland Oilers and the Clear Falls Knights.

Trailing 41-36 with 9:06 to play in the fourth quarter, Pearland senior quarterback Cole Morkovsky found Jordan "the Jet" Hernandez open down the right sideline and the speedster outran the coverage to score the winning points. With the score tied 41-41, senior kicker Jackson Stagg calmly booted the extra point for a 42-41 Pearland

Stagg would later step up with 1:53 remaining in the game and seal the contest with a clutch

39-yard field goal to post the 45-41 final score in favor of the Oilers.

The win avenges last year's loss to the Knights 20-17 when Pearland missed a late game field goal and the Knights ran out the clock to preserve the win.

"I told the kids after the game one of the things that made me most proud was the fact that there were plenty of opportunities for them to hang their heads," Gotte said. "Instead, they kept battling and that type of persistence, focus and believe in one anoth-




"Our defense played lights out, but I don't know how many three-and-outs we had. We also had false starts, busts, personal fouls and unforced turnovers.
