

# Public hearing on tax increase set Monday

A public hearing and first reading of the City of Pearland's budget is set for Monday, Sept. 11, at City Hall, 3519 Liberty Drive. A second reading and public hearing on the city tax

Proposed is a maximum total tax rate of 65.54 cents per \$100 of property value, about 10 cents above the

rate is set for Sept. 25. Both meetings begin at 6:30

no-new-revenue rate. The prior year's tax rate -- which city leaders have emphasized was artificially low due to a budgeting er-

The City of Pearland found itself in the news last year when a valuation error created a \$10 million bud-

"Imagine getting hit in the gut and what that does to you," Mayor Kevin Cole said during an Aug. 23 ques-

tion-and-answer forum. "We were able to withstand that. Could we do it again this year? Probably not -- it would be tough."

Through a series of budget amendments to help shore up the differences that include dipping into reserves, reallocating federal funds and deferred payments into its vehicle fund.

The motor pool fund, as it is known, is maintained to replace and repair the large fleet of city vehicles. The city makes regular payments into that fund during the year, which allows it to pay cash for vehicles rather than borrowing or leasing.

"Probably the biggest single line item (deferred) was the motor pool fund," Cole said. "There was a lot of little things we did - we were so far moving forward with capital improvement projects that if we delayed something it didn't have an impact on this budget."

# Level 2 drought plan: Watering limited, splash pads close

Increased demand on the city's water system prompted Pearland to enter Stage 2 of its drought contingency, implementing mandatory watering sched-

Under stage 2, residents are restricted to watering lawns on the days they have trash service scheduled.

"You can still water your grass but we're asking you to limit it to two days a week," Mayor Kevin Cole said in the Aug. 30 announcement. "Do it on the days you have garbage collection; it's easy to remember

that way." In addition, the following are prohibited under

- Watering lawns between 9 a.m. and 7 p.m.

- Operating pond fountains or interactive water features

- Draining and refilling of swimming pools.

Violations of restrictions can result in a fine of up to \$2,000. The city's Centennial and Southdown Park splash pads are closed until further notice.

"We have to have the supply to provide central services such as fighting a fire or making sure you have enough drinking water," Cole said.

# Talk of the Town:

# 'Who paid for those pears?' Forums answer FAQs

City leaders tackled questions ranging from who paid giant pear sculptures to the city's homestead exemptions during a town hall style discussion Aug. 23.

Held each quarter on a different topic, Talk of the Town allows residents to ask questions and engage in dialogue with city officials. "We try to find something relevant to what's

going on in our city during that particular quarter," Mayor Kevin Cole said. The next Talk of the Town is planned for November with details to be announced.

### 288 Beautification

A frequent question he is asked, Cole said, is how beautification along the Highway 288 corridor -- which include the city's highly visible pear sculptures -- is funded.

"The funding sources is actually the Pearland Economic Development Corp.; they have a half-cent sales tax that goes to economic development and other improvements in the community that benefit economic development," City Manager Trent Epperson said. "You know

when you've arrived in Pearland. We fund the

construction through the EDC; that's not part of

your property taxes."

Maintained by a management district, the beautification corridor is designed to help attract business investments.

"It is an attraction tool. Companies are going to invest \$20 (million) or \$100 million in your community, it's just like when you buy a home," Mayor Cole said. "You're going to look the neighborhood up."

## Property tax relief

The forum included a discussion on the city's budget for the upcoming tax year that begins in October. In November, Texas voters will decide on a significant increase on school district taxes, which likely will be reflected in residents' the state, Cole pointed out.

tax bills. The missing revenue will come from "(Cities) don't have that option; the state doesn't fund us like they do schools," he said. "If we do something with the homestead tax

exemption, it's going to have an impact somewhere." A discussion on how increasing the city's current 2.5 percent homestead exemption will

likely happen in October, Cole said. "We need to have an honest discussion about where does that money come from," he said.

'We'd like to attract more companies and want to make sure they're welcome in our community as well."

### **Bond project updates**

Introduced at the forum was city's new engineering and public works director, Lorenzo Wingate, a Beaumont native who joined the Pearland staff from La Porte.

Wingate provided an update on the city's 2019 bond referendum projects. The largest of these yet to begin construction is Bailey Road improvements. Those will begin this fall and are expected to be completed in 2025.

A 2023 bond election was driven largely by drainage projects that drew the most voter support, Mayor Cole said. All four propositions "We are moving one of those projects from

debt service on your property tax to the Economic Development Corporation," Cole said. "They're going to pick up the Hickory Slough Sports complex after the detention is done and take on roughly a \$17 million project through their resources that won't come to your property tax. We want to make sure we're listening to that 48 percent that voted no."

# UHCL autism research, resources reach national audience in Nigeria

University of Houston-Clear Lake's Telehealth ABA World Project has been empowering parents and professionals who work with children with autism around the world by connecting them with therapists who can provide interactive video services on the internet. The Project's reach has extended to Nigeria, where the expertise of the Project's Program Manager Loukia Tsami was shared on national television earlier this month.

"We have been offering resources and support to parents of children with autism in Nigeria for a long time," Tsami said. "I was doing a virtual presentation in Liberia and I was seen by a Nigerian speech pathologist named Maryam Ibrahim, who works with autistic children there. She said I should do this presentation in Nigeria as well."

Tsami said that with the collaboration of Ibrahim and another colleague in the Oputu Learning Center and other community professionals, they were able to organize an event that brought in over 150 attendees.

Tsami said that her presentation, which discussed the inclusion of people with disabilities in healthcare, was shown on a nationally-televised news program—an indication of positive change for people with developmental disabilities in Nigeria.

"The name of the event was called, 'Acceptance and Inclusion of Special Needs Children in Healthcare, the Classroom and Society," she said. "The television media presence at the event was one of the first times this topic was ever discussed in a public forum. The event was shown on both national Nigerian television in English, and in Kaduna, which is the capital of Kaduna State in northwest Nigeria, in the local language."

She said that the main challenge in improving the lives of people with disabilities in Nigeria was simply education.

"There is a strong stigma attached to people with disabilities, but the community seems to be changing," she said. "I was talking about the power of including people with disabilities into the healthcare environment, and the fact that this topic was shown on national television to millions of viewers is very important. This way, our message had another level of reach and potential impact in a place where this information is still

In her presentation, she spoke about the research being conducted at UH-Clear Lake, how it can be applied in different environments, and how it can be modified to apply in different cultures.

"Some are becoming more open to the idea of inclusion in schools and healthcare, but others are still puzzled by this," she said. "We are sharing our knowledge and research with the world, particularly in places in which these messages are rarely if ever heard. The national TV coverage is important, but the fact that it happened in Nigeria is exceptional. Nigeria leads the continent of Africa; their impact is greater."

Since 2015, the Telehealth ABA World Project has been passionate about bringing critical services via telehealth and resources to families and professionals who work with children with autism in over 34 countries, including in Mexico, Costa Rica, Greece, Cameroon, and Nigeria. The Project finds creative ways to offer services in locations that otherwise go without access.

About the middle of the feast Jesus went up into the temple and taught. 15 The Jews marveled at it, saying, "How is it that this man has learning,[c] when he has never studied?" 16 So Jesus answered them, "My teaching is not mine, but his who sent me; 17 if any man's will is to do his will, he shall know whether the teaching is from God or whether I am speaking on my own author--John 7:14-17

"Paul, a servant of Christ Jesus, called to be an apostle and set apart for the pel he promised beforehand through his prophets in the Holy Scriptures 3 regarding his Son, who as to his earthly life was a descendant of David, 4 and who through the Spirit of holiness was appointed the Son of God in power by his resurrection from the dead: Jesus Christ our Lord." -Romans 1:1-4



## Pearland crushes Memorial 55-21 to remain unbeaten

Establishing control of the game against Spring Branch Memorial at the very beginning was important for the Oilers

Pearland and Memorial have been long-time opponents with Pearland owning the rivalry with a 14-3 edge.

The Oilers got the opening kickoff and came out with a 12-play, 68-yard scoring drive that took have of the first quarter.

Junior running back LaDamion McDowell was the workhorse of the drive carrying the ball for seven of the 12 plays capped off with a 4-yard scoring run with 6:15 left in the first quarter. Jackson Stagg tacked on the extra point for a 7-0 lead

On Memorial's first drive from the Pearland 42 to the 4, the Mustangs opted to kick a 21-yard field goal but the kick missed the mark leaving the Oilers with a 7-0 lead.

Pearland took over on their own 20 and QB Cole Morkovsky promptly hit Jordan "The Jet" Hernandez on a pass down the left sideline for an 80-yard touchdown and the rout was on. Stagg hit the PAT and Pearland was ahead 14-0 with 1:06 remaining in the opening quarter.

After the Pearland defense forced Memorial to punt, the Oilers began their third drive of the game from their own 43. A pass to WR Patrick Bridges and a 22-yard run by McDowell placed the ball at the Memorial 25.

Morkovsky called The Jet's number again on an end sweep and Hernanez burned the Mustangs on a 25-yard dash around left end. Stagg once again hit the PAT for a 21-0 lead with 11:16 left in the second quarter.

Memorial finally got Pearland to turn the ball over with a fumble on the Oiler 17. The Mustangs scored on a five-play, 17-yard drive with a 7-yard scoring toss to make the score 21-7 with 5:51 left before halftime.

The Oilers would score two more times on a McDowell

### Caution urged as hunting season opens

# Future engineers gain hands on experience

With education abroad, college students can experience new places and cultures, all while earning credits toward their degrees'. Students also acquire skills that employers are looking for such as leadership, communication adaptability and teamwork with people from different backgrounds. Four University of Houston Clear Lake College of Science and Engineering students studied abroad in Darmstadt, Germany this past summer to complete the 'German Engineering and Language' program. This six-week program is designed to provide insights into cutting-edge German engineering technology, to improve students' foreign language skills, and to learn more about German culture.

Trey Carsner, Ros'Lynn Charles, Alexej Gobert, and Isaiah Roque, all experienced German culture, while taking German language courses, attending

engineering courses and workshops and cross-cultural competencies training. The program focused on mechanical and electrical engineering.

They completed their German language courses virtually, and then traveled to Darmstadt to complete their in-person courses and trainings. For engineers, Germany is an especially attractive study-abroad destination because it's known as one of the leading engineering and manufacturing countries in the world, and is home to internationally known brands like Audi, BMW, Siemens, Daimler and many

Ros'Lynn Charles is a senior pursuing her Bachelor of Science in Mechanical Engineering. She aspires to be an automotive mechanical engineer and said the program and classes she attended helped prepare her for her future

You can choose which engineering track you want to follow. I am interested in automotive, and what I learned will help me when I start manufacturing things. Our labs consisted of hands on work with machines, not just learning from a textbook," she said. "They took us to the field, to different companies, and to a track to drive cars."

Charles said that she would recommend study abroad to other engineering students. She said it could remove them from their comfort zones, and also help them find a sense of independence.

"People can be afraid, and that deters them from studying abroad. I did not know the three other guys that went on the trip until we arrived at the airport. Three of us had been out of the country, and one of us hadn't," she explained.

"At the beginning of our trip, the one

who hadn't been out of the country

was the least familiar with traveling

the trip, he was the one taking all of the trains by himself and able to maneuver without the rest of us."

She added traveling with a "buddy system" in place was beneficial for them when they were feeling homesick, and for safety purposes. She said UH-CL's Education Abroad and Scholar Services did a great job lining everything up for them to be comfortable, and offered guidance and support throughout the process.

Global Scholar Adviser II Larisa Landry said Education Abroad and Scholar Services would love to send

more engineering students to Germany next summer. "The program will be available next year, and we will be assisting students. It is important for them to apply as soon

as possible, because the program is

open to students from all over the world,

and public transportation. By the end of and this makes it very competitive," she said. "It is a lengthy process and it takes time, but we provide them with support from the very beginning. We help them communicate with each other and partners in Germany, and provide them with a predeparture orientation."

> Landry added that they inform students of any mishaps that could happen, what type of travel insurance they will need, risks and more. The department likes to have students fully prepared before traveling.

> "We understand that many of our students have never been abroad," Landry said. "But the benefit of this program, is that our Germany partners provide airport pick-up, 24-hour assistance to the students, and work closely with us to provide safety to students."

Students earn three classroom credits for completing study abroad at UHCL.
